

# MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS.
This Memorandum of Agreement made and entered into this day of,  202at Tuguegarao City, Philippines by and between:
The <b>PROVINCIAL GOVERNMENT OF CAGAYAN</b> with principal office at the Capitol Hills, Tuguegarao City, Cagayan, herein represented by its Provincial Governor, <b>MANUEL MAMBA</b> , herein referred to as the <b>First Party</b> ;
and
TUGUEGARAO CITY represented by its Mayor MAILA ROSARIO S. TING-QUE and herein referred to as the Second Party;
WITNESSETH:
<b>WHEREAS</b> , under Section 33 of RA 7160 otherwise known as the Local Government Code of 1991, Local Government Units may undertake cooperative undertakings for the common benefit of their constituents;
WHEREAS, the Provincial Government of Cagayan sees the importance of such joint undertaking for effective local governance in promoting good governance and general welfare;
whereas, the Provincial Government of Cagayan is extending financial assistance amounting to funded under the CY 2023 Development Assistance to LGUs of the Province (which shall be herewith referred to as Project Fund) to the Second Party for the which shall herewith referred to as the project;
