



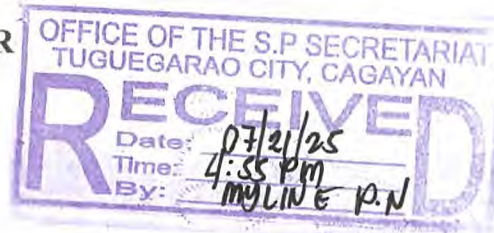



Council Resolution No. 2 series of 2025

**RESOLUTION RECOMMENDING THE LIFTING OF THE STATE OF CALAMITY IN
TUGUEGARAO CITY DUE TO TYPHOON “KRISTINE”, AS RECOMMENDED BY
THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL
(CDRRMC)**

WHEREAS, the Sangguniang Panglungsod of Tuguegarao, through City Resolution No. 601-09-2024, declared the entire City of Tuguegarao under a State of Calamity on October 28, 2024, following the extensive damage caused by Severe Tropical Storm “Kristine” to agriculture, infrastructure and livelihood in Tuguegarao City.

WHEREAS, after a comprehensive assessment and evaluation conducted by the City Disaster Risk Reduction and Management Office (CDRRMO) and in coordination with the concerned Barangay, it has been confirmed that the conditions that necessitated the declaration of a State of Calamity have significantly improved;

WHEREAS, the successful implementation of response and recovery programs, including the distribution of relief goods, utilization of the Quick Response Fund (QRF), and support to displaced families and affected communities, have led to the restoration of normalcy in the majority of the affected areas; and,

WHEREAS, the CDRRMC has issued Resolution No. 2, series of 2025 recommending the lifting of the State of Calamity in Tuguegarao City effective January 20, 2025.

NOW THEREFORE, on motion of PInst. Gilbert Pajarillo, duly seconded, be it:

RESOLVED, AS IT IS HEREBY RESOLVED TO RECOMMEND TO LIFT THE STATE OF CALAMITY IN TUGUEGARAO CITY DUE TO SEVERE TROPICAL STORM “KRISTINE”, AS RECOMMENDED BY THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC)

RESOLVED FINALLY, to furnish copies of this Resolution to the Department of the Interior and Local Government (DILG), Provincial Disaster Risk Reduction and Management Office (PDRRMO), Sanggunian Panglungsod and all concerned agencies for their information and appropriate action.
