Tuguegarao City journos secure 4 major wins at 2024 NSPC

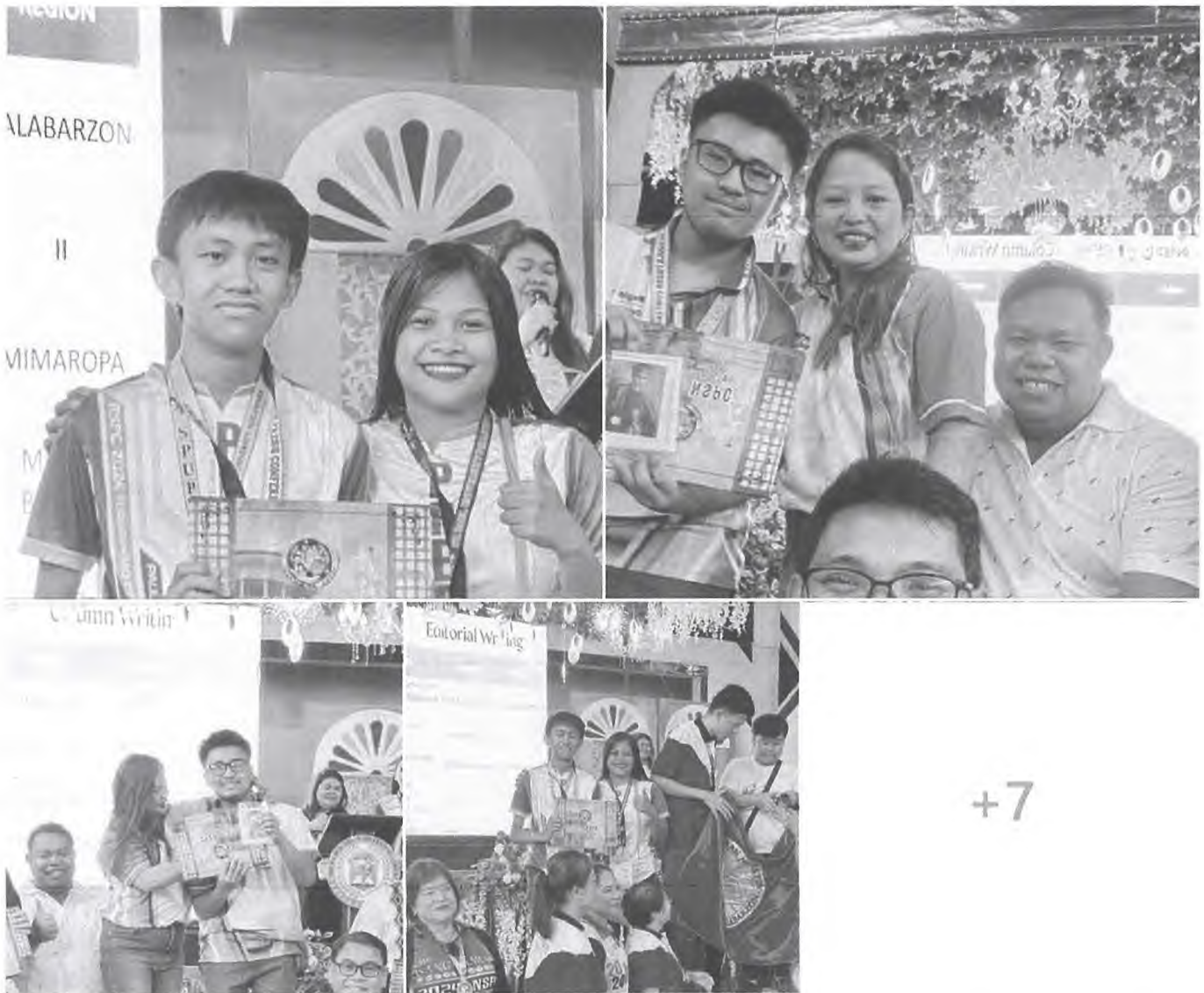
