

As per evaluation of the documents, it has been noted that the certain section which was deleted forms an integral part of the tripartite agreement as per DHSUD Department Circular No. 2024-019 (2024 Updated 4PH Operations Manual). Its inclusion is necessary for alignment and consistency with national guidelines. As per record a similar tripartite agreement passed by the Sangguniang Panlungsod under City Resolution No. 484-09-2023 dated October 24, 2023 and the said section was not deleted. The Sangguniang may suggest the rewording/rephrasing of the section can be done for their convenience.
