

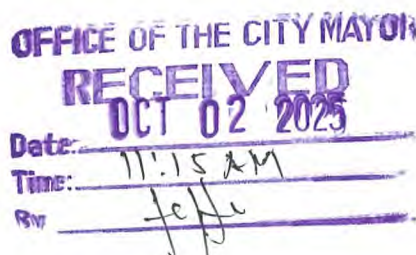


Greetings!

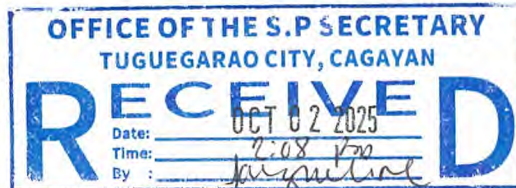
