BARANGAY ORDINANCE NO. 1
Series of 2024

ADOPTING BARANGAY ORDINANCE NO.2 SERIES OF 2020 AUTHORIZING THE CITY OF TUGUEGARAO TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEES IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER

WHEREAS, under Section 152 (C) of the Local Government Code states that ;

“(C) **Barangay Clearance** - No City or Municipality may issue any license or permit for any business or activity unless a clearance is first obtained from the Barangay where such business or activity is located or conducted. For such clearance , the Sangguniang Barangay may impose a reasonable fee. The application for clearance shall be acted upon within seven (7) working days from the filing thereof, in the event that the clearance is not issued within the said period, the City or Municipality may issue the said license or permit.”

WHEREAS, the EODB ACT of 2018 Or the Republic Act 11032, otherwise known as “An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services, Amending for the Purpose of Republic Act No. 9485 “ was” duly enacted;

WHEREAS, Section 11 (f) of the above-mentioned Republic Act duly amended the Section 152 (C) of the Local Government Code and provides that “ Barangay clearances and permits related to doing business shall be applied, issued and collected at the City in accordance with the prescribed processing time of said Act, Provided that the share in the collection shall be remitted to respective Barangays, and

WHEREAS, Barangay Balzain East, (Centro 11), in accordance with the above provisions, and as an implementation of “ONE STOP SHOP “, hereby authorizes the City of Tuguegarao to issue Barangay Clearance and collect corresponding Barangay clearance fee in the application for any business-related transactions subject to the remittance of the aforesaid fees to the Barangay and the conditions hereunder.

NOW THEREFORE, be it **ORDAINED** as it is hereby **ORDAINED** by the Barangay Council of Balzain East,(Centro 11), in a session duly assembled the following :

SECTION 1. Coverage. This policy applies only to the issuance of Barangay Clearance for business permit and locational clearance as a requirement for the issuance of building permit at the City. Other clearances for other purposes shall still be obtained at the Barangay.

This circular shall cover all City and Municipal Mayors, Punong Barangays, Concerned Local Officials, DILG Regional Directors and BARRMM Minister of Local Government and all other concerned.

SECTION 2. Definition of Terms. The words and phrases used in this ordinance are hereby defined as follows;

Barangay Clearance - refers to any and all documents issued by the Barangays with or without corresponding fees as defined in their ordinances relative to or in relation to the issuance of business permit and locational /zoning clearance by the City or any other permit as may be required, (IRR of RA 11032).

Barangay Clearance Fees - is an amount imposed by the Barangay through an Ordinance and collected by the City in relation to the issuance of business permit and locational/zoning clearance by the City.

Business Permit - is a document that must be secured from the City Government usually through its Business Permits and Licensing Office (BPLO) for a business to legally operate in the locality.(IRR of RA 11032).

Locational Clearance - is a clearance issued by the Zoning Administrator Officer to a project that is allowed under the provisions of an ordinance of a particular City. It is a requirement for the issuance of Building Permit. (House and Land use Regulatory Board) - Comprehensive Land Use Plan (Guidebook).

SECTION 3 - Authority to collect Barangay Clearance Fee of Business- Related Transactions - The City of Tuguegarao is given authority to Collect Barangay Clearance for subject to the remittance to the subject Barangay.

SECTION 4. Rate of Barangay Clearance Fee to be collected - The rate of Barangay Clearance Fee to be collected by the City for the issuance of clearance shall be computed in accordance with the subject Barangay Revenue Ordinance herein attached as "ANNEX A" and made as an integral part hereof.

SECTION 5. Barangay Clearance Signatory - Electronic Signature of Punong Barangay concerned shall appear in all Barangay Clearance issued.

SECTION 6. Reporting and Remittance - The City shall remit the Barangay Clearance fee collected to the subject Barangay not later than seven (7) working days of the ensuing month with the list of the issued Building and Business Permit.

SECTION 7. Separability Clause - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 8. Repealing Clause - All previous Ordinance and rules/regulations which are inconsistent with the provisions of the ordinance are hereby deemed, modified or repealed accordingly.

ORDINANCE NO.1-2020

Be it enacted by the Sangguniang Barangay that :

Section 1. **TITLE**

This ordinance shall be entitled :” BARANGAY REVENUE ORDINANCE NO.1 series of 2024” as amended.

Section 11. **SCOPE**

This ordinance shall govern the exercise of the taxing powers and other revenues of Barangay Balzain East (Centro 11), Tuguegarao City, Cagayan.

Section 111. **DEFINITION OF TERMS**

As issued in this ordinance, the following terms shall be construed to mean as follows :

A) TAXES - a compulsory contribution levied upon persons, property or business for the support of the government.

B) FEES - a charge fixed by law for services of public officers or for use of privilege under control of government.

C)) CHARGES - income derived by the Barangay LGU in its proprietary functions, such as, market stall rentals, medical and dental charges, garbage collections, transportation fares and sale of goods, gym rentals and property rentals such as canopy, chairs and tables for private use.

D) WHOLESALE - where the purchaser buys the commodities for sale regardless of the quantity of the commodity sold.

E) RETAIL - sale w where the purchaser buys the commodity for his own consumption irrespective of the quantity of the commodity sold.

F) AMUSEMENT PLACES - are establishments devoted to pleasurable diversion and entertainment, such as videoke bars, billiards and other activities for fun and pastime.

G) COMMERCIAL BREEDING COCKS

Section 1V. **RULE OF CONSTRUCTION**

All provisions of this ordinance shall be liberally in favor of the taxpayers and strictly against Barangay LGU's.

Section V. IMPOSITION OF TAXES

It is hereby imposed on the following persons to establish, operate, conduct or maintain their respective businesses within the Barangay a business tax on stores or retailers with gross sales or receipts of the preceding calendar year of FIFTY THOUSAND (P50,000.00) PESOS or less not exceeding one percent (1%) on gross sales or receipts of the preceding year.

Section V1. PAYMENT OF BUSINESS TAXES

Business taxes shall be paid by the person conducting the same to the Barangay Treasurer or any authorized representative on or before the 31st of March of every year.

In cases where the person conduct or operates two (2) or more business which are subject to the same rate, the tax shall be computed on the basis of the combined total gross sales or receipts. The Barangay Treasurer shall issue official receipts and deposit all collection to the depository account of the Barangay.

Section V11. RETIREMENT OF BUSINESS

Any person, subject on the business shall, upon termination of the business, notify in writing the Barangay Treasurer and submit a sworn statement of the gross sales or receipts for the current calendar year. Investigation shall then follow to ensure that the business have stopped operation. If found out that the business is still operational, the owner shall be held liable for the taxes imposed

Section V111. REGULATORY FEES, CHARGES AND PERMIT

Section 1X. **TIME AND MANNER OF PAYMENT**

The tax, fees and charges shall be paid to the Barangay Treasurer or any authorized representative at the time of the request, written or otherwise, for the issuance of the Barangay Clearance and Barangay Certification. An official receipt shall be issued by the Barangay Treasurer to the payor as evidence of payment.

Section X. **PENAL PROVISION**

Violators of this ordinance shall be penalized as follows :

- a. A surcharge of 12%/annum shall be imposed on Violation of Section V, Section VII and Section VIII of this Ordinance;
- b. On Section VIII of this Ordinance, the Barangay Tanods, Barangay Officials shall be deputized to remove any facility installed without the necessary permit or clearance.

Section XI. **EFFECTIVITY**

This Barangay Revenue Ordinance shall take effect immediately upon approval.

RESOLUTION NO. I
Series of 2023

“A RESOLUTION OF THE BARANGAY REVENUE ORDINANCE OF BARANGAY BALZAIN EAST, TUGUEGARAO CITY, CAGAYAN”

WHEREAS, all LGU’s are empowered to create their own sources of revenues and to levy taxes, fees and charges, subject to the provisions on local taxation consistent with the basic policy of local autonomy (Local Government Code, Section 129).

WHEREAS, one of the fundamental principles governing the exercise of the taxing and other revenue-raising power of LGU’s is that : taxation shall in form be in each local government unit (Local Government Code, Section 130).

NOW THEREFORE, RESOLVE as it is hereby RESOLVED by this Body in the regular session to pass a resolution of Barangay Revenue Ordinance of Balzain East.
