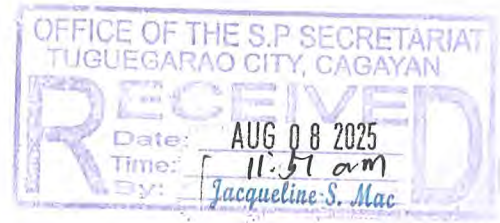



- Burgos Street – from Gonzaga Street to Luna Street


