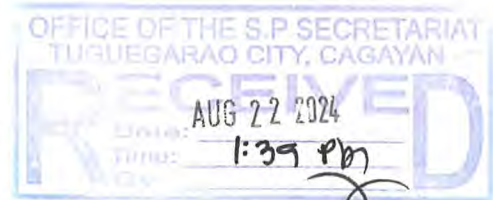




Ladies and Gentlemen:

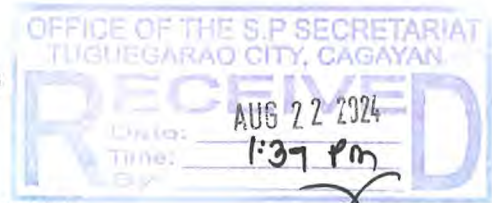

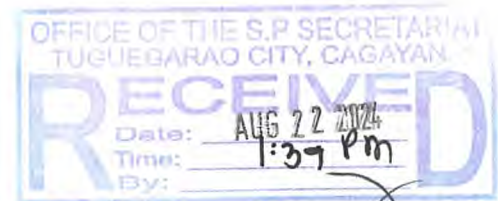


Ladies and Gentlemen:

Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Supplemental Budget No. 1 for CY 2024 of Barangay Centro 02** in the amount of **Five Hundred Thousand Pesos (P 500,000.00)** approved through **SK Resolution No. 4-2024** on July 14, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.


