### DESIGNATION OF ACTING ASSISTANT CITY TREASURER OF TUGUEGARAO CITY, CAGAYAN

In the exigencies of the service and in view of the representations made by Mayor Maila Rosario S. Ting-que of Tuguegarao City, Cagayan and the Bureau of Local Government Finance (BLGF), Ms. EVELYN L. CANAPI, Local Treasury Operations Officer III, City Treasurer's Office, Tuguegarao City, Cagayan, is hereby designated as Acting Assistant City Treasurer, same city, effective upon approval hereof and actual assumption thereat up to but not beyond a period of one (1) year, unless sooner revoked, which should be reported to the BLGF Regional Office No. II, pending the appointment of a regular Assistant City Treasurer thereat.

Ms. Canapi shall be guided by the provisions of the Local Treasury Operations Manual (LTOM) 2<sup>nd</sup> Edition, and all applicable laws, rules and regulations necessary in the performance of her official duties and functions, including the bonding requirements, relative to this Order. As may be applicable, the turnover of office, together with cash, properties and equipment, books of accounts, including cash books and accountable forms, among others, shall be effected in accordance with the LTOM 2<sup>nd</sup> Edition and the Government Accounting and Auditing Manual.

As the Acting Assistant City Treasurer of Tuguegarao City, Cagayan, Ms. Canapi shall receive the representation allowance and/or transportation allowance (RA/TA) authorized for the Assistant City Treasurer position, including per diems if on official travel outside her station, subject to the usual auditing and accounting rules and regulations. Accordingly, she shall continue to receive her salary and other benefits commensurate to her position as Local Treasury Operations Officer III.

All issuances inconsistent herewith are hereby revoked. The BLGF shall provide all concerned with a copy of this Order for their reference and guidance.
