Ladies and Gentlemen:

Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Annual Budget for CY 2024 of Barangay Caritan Centro** in the amount of **Six Hundred Fourteen Thousand Eight Hundred Five Pesos and Twenty Fifty Centavos (P 614,805.50)** approved through **SK Resolution No. 1-2024** on January 7, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.
