

#### ORDINANCE No. 01 Series of 2024

# AN ORDINANCE ADOPTING A NEW OFFICIAL SEAL OF BARANGAY UGAC NORTE, TUGUEGARAO CITY, CAGAYAN, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL/UNAUTHORIZED USE THEREOF

WHEREAS, Barangay Ugac Norte recognized the need for the council to have a logo/seal that will best represent the principles and aspirations of the body;

WHEREAS, Barangay Ugac Norte is likewise necessary to identify official transactions and documents of the Sanggunian;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF UGAC NORTE, TUGUEGARAO CITY, AS FOLLOWS:

**SECTION 1. Official Logo/Seal.** The official logo/seal of the Sangguniang Barangay of Ugac Norte, Tuguegarao City shall be as depicted below:



1. **TORCH WITH FLAME** – the torch symbolizes wisdom and knowledge as the fundamentals of good governance of the Barangay.

The 3 man-flame depicts the people of the Barangay as the source of strength for a more united and resilient community.

- 2. **DOVE** symbolizes the faith of the people of Barangay Ugac Norte.
- 3. **SHIELD** symbolizes Peace and Security. The color of the shield depicts the Philippine Flag with its three major colors White, Blue and Red.

□ Color White - symbolizes unity, freedom, people's democracy, and sovereignty.

- ☐ Color Blue symbolizes peace, truth, and justice.
- ☐ Color Red symbolizes patriotism and valor.
- 4. **BUILDINGS** symbolizes the Progress of Barangay Ugac Norte, being one of the barangays with fast growing economy in terms of modernization and development.
- 5. **LEAVES** symbolizes the commitment and dedication of Barangay Ugac Norte towards becoming a nature and an environment friendly barangay.
- **6. WHITE LETTERING in NAVY BLUE BACKGROUND** symbolizes Purity and Cleanliness (white) and Trust and Stability (navy Blue).

**SECTION 2. Purpose of Seal and Authorized Use of Logo/Seal.** The official logo/seal of the Sangguniang Barangay shall be for official purposes only. It shall appear in all official documents of the Sangguniang Barangay and in circumstances where the Sanggunian permits the use thereof.

**SECTION 3. Unauthorized use of the logo/seal.** It shall be unlawful for any person, natural or juridical, to print the official logo/seal of the Sangguniang Barangay for purpose of sale, distribution or circulate, manufacture, publish, use, display or offer for sale any document or items, merchandise which simulate the official logo/seal of the Sangguniang Barangay without the express written consent of the Sangguniang Barangay.

Any violation of this provision shall be punishable by an imprisonment of not more than thirty (30) days or a fine of not more than Five Thousand Pesos (P5,000.00) or both, subject to the discretion of the courts.

**SECTION 4. Separability.** In the event that a part of this ordinance be declared invalid, the remaining provisions not declared so shall stand effective.

SECTION 5. Repealing Clause. Any ordinance or measure found to be inconsistent with this ordinance shall be deemed repealed.

**SECTION 6. Effectivity.** The ordinance shall take effect upon its approval.
