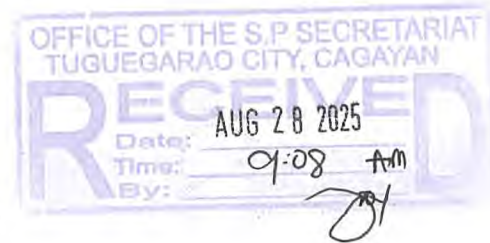

WHEREAS, Republic Act 8491 or the Flag and Heraldic Code of the Philippines mandates that "reverence and respect shall at all times be accorded the flag, the anthem and other national symbols which embody the national ideals and traditions and which express the principles of sovereignty and national solidarity."

WHEREAS, the Philippine Flag is the national symbol of the Republic of the Philippines and embodies national honor and dignity of every Filipino;

WHEREAS, the singing of the national anthem and displaying the Philippine flag during government activities, programs, seminars and training instil Filipino patriotism, love of the country, fostering national solidarity and respect for national symbols as mandated by law.

WHEREAS, business establishments operating as seminar venues and function halls are utilized for public and private gatherings, civic events, and national celebrations;

WHEREAS, some government agencies chose to hold their activities, programs, seminars and trainings in private function halls/ facilities wherein the singing of the national anthem and raising of the National Flag is required to start the program proper;

WHEREAS, it has been observed that some business establishments operating as seminar venues and function halls in Tuguegarao City do not have indoor flagpoles for the purpose as stated above:

WHEREAS, it is hereby requested for business establishments operating or maintaining seminar venues and/or function halls to provide floor base for indoor flagpole in a conspicuous and appropriate location within their premises for the proper display of the Philippine Flag.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED,** to REQUEST BUSINESS ESTABLISHMENTS WITH SEMINAR VENUES AND FUNCTION HALL FACILITIES WITHIN THE TUGUEGARAO CITY TO PROVIDE FLOOR STAND BASE FOR INDOOR FLAGPOLES FOR THE DISPLAY OF THE PHILIPPINE FLAG.
