

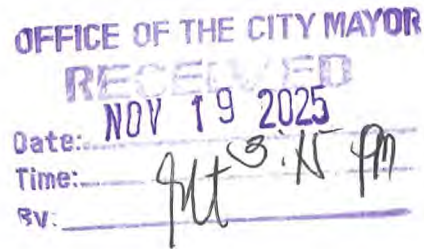

BOARD RESOLUTION NO. 01-2025

RESOLUTION AUTHORIZING MR. RONALD R. PABLO OF BARANGAY PENGUE-RUYU, TUGUEGARAO CITY TO APPLY FOR A CHANGE OF UNIT FOR HIS TRICYCLE COVERED BY PROVISIONAL AUTHORITY TO OPERATE TRICYCLE FOR HIRE WITH CASE NO.97-5933 WITH PLATE NO. 664BOG

WHEREAS, Mr. Ronald R. Pablo, a resident of Barangay Pengue-Ruyu, has been granted a provisional authority to operate a motorized tricycle service in Tuguegarao City with FRANCHISE CASE NO. 97-5933 from August 14, 2024 to April 14, 2026:

WHEREAS, the motorcycle unit of the said tricycle for hire is described as **MOTO POSH PINOY 155, bearing MV FILE NO. 020100000984267 with ENGINE NO. 162FMJJH046537 and CHASSIS NO. MT7LC6308M0046537 with BODY TYPE TRICYCLE TC. FRANCHISE NO. 97-5933:**

WHEREAS, on October 2, 2025 at around 6:50 pm to 6:53 PM, the subject tricycle unit was engaged in a vehicular accident resulting to the total wreckage of the motorcycle, thereby causing the said motorized tricycle to be no longer roadworthy, dependable, and highly reliable tricycle in accordance with Section 16 (b) of the City Ordinance No. 08-2013;

WHEREAS, in support of the application for a change of unit, the following attached documents were evaluated by the Members of the Board as required by the City Ordinance No. 08-2013:

1. Police Report dated October 2, 2025
2. Recommendation on the Application for a Change of Unit of Mr. Ronald R. Pablo dated October 28, 2025 by Atty. Roderick S. Iquin, the City Legal Officer
3. Memorandum of Understanding executed by and among the parties involved in the vehicular accident
4. Photocopies of the motorcycle unit after the vehicular accident
5. Official receipt of LTO Registration and Certificate of Registration
6. Copy of Authority to Operate Tricycle for Hire issued by the City Franchising Board

WHEREAS, after a thorough discussion and deliberation, the Board finds it proper for Mr. Ronald R. Pablo to apply for a Change of Unit considering that the subject Motor Vehicle is no longer roadworthy, dependable, and highly reliable tricycle due to circumstances beyond his control:

WHEREAS, Mr. Ronald R. Pablo shall be required to change the destroyed unit with a **"FOUR STROKE ENGINE"** and to comply with the requirements as provided under City Ordinance No. 08-2013 and to pay the fees for Change of Unit.

NOW, THEREFORE, for and in consideration of the request of Mr. Ronald R. Pablo, the Board resolves to grant his request for a Change of Unit of his franchise.
