### BARANGAY ORDINANCE NO. 20 - 2024

#### AN ORDINANCE SETTING-UP BARANGAY COMMUNITY GARDENS AND ALLOCATING FUNDS THEREOF FOR THE IMPLEMENTATION OF THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROJECT

**WHEREAS**, there is a recent report about the rising number of families experiencing hunger in the country which was recorded at 12.6% based on the latest survey by the Social Weather Station (SWS);

**WHEREAS**, a Memorandum Circular No. 47 signed by Executive Secretary Lucas Bersamin in April 19, 2024, enjoining all government agencies and Local Government Units (LGUs) to support the implementation of Enhance Partnership Against Hunger and Poverty (EPAHP) Program to mitigate hunger and promote food and nutrition security;

**WHEREAS**, Section 17. Basic Services and Facilities (a) of LG Code state that local government units shall endeavor to be self-reliant and shall continue expressing the powers and discharging the duties and functions the most significant devolved national resources, social services, public works, funded by local funds;

**WHEREAS**, DILG Memorandum Circular No. 2023-001 was issued introducing the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project which aims to strengthen the capacities of barangays towards sustainable agriculture initiatives to include agriculture-related activities such as barangay community gardening wherein household are encourage to have their own backyard garden.

**NOW THEREFOR**, on motion of Hon. Edmund P. Pancha, duly seconded by Hon. Nemecio Gannaban, the body has:

**RESOLVED, AS IT IS HEREBY RESOLVED TO ENACT THE ORDINANCE.**

**SECTION 1. TITLE.** This ordinance shall be known as Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project Ordinance in Barangay Cataggaman Viejo.

**SECTION 2. DEFINITIONS.** As used in this ordinance, the following words and phrases shall mean and be construed as hereunder indicated:

- a. Barangay Community Garden – shall refer to a piece of lot or land operated and cultivated by the barangay for the purpose of planting and growing vegetables and fruit-bearing trees.
- b. Container Gardening – refer to the micro model farming where a family or household is producing vegetables and fruits in special containers.
- c. Hydroponics – a method of growing vegetables using material nutrient solutions in a water without soil (soil less-based)
- d. Backyard Garden – refers to a family or household-managed gardening at their own yard for family consumption.

**SECTION 3. ESTABLISHMENT OF COMMUNITY GARDEN**

- a. The community garden shall be established in an available site/s to be determined by the Sangguniang Barangay.
- b. In establishing the community garden, the Sangguniang Barangay shall identify which vegetable plants, herbal plants of root crops they wish to grow.
- c. The Sangguniang Barangay can also coordinate, enter into agreement with private individuals who own a vacant lot to be used to establish the barangay community garden.
- d. The Sangguniang Barangay can also establish community garden by using or implementing alternative gardening such as container and hydroponics.
- e. Moreover, the Sangguniang Barangay shall encourage their residents to set-up their own backyard garden and plant fruit-bearing trees.

**SECTION 4. ROLES AND RESPONSIBILITIES OF THE SANGGUNIANG BARANGAY**

- a. Ensure the strengthening of the Barangay Nutrition Committee;
- b. Include in the Barangay Development Plan and Annual Investment Programs, applicable nutritional programs, projects and activities to ensure adequate funding for nutritional impact;
- c. Ensure the updating of the Barangay Nutrition Plan in line with the full devolution, to include the establishment and maintenance of Barangay Community Garden, provision of seeding materials, and agriculture equipment among others;
- d. Designate the Chairperson of the Committee on Agriculture, to lead and manage the establishment and maintenance of the barangay community garden through an Executive Order;
- e. Designate other barangay officials and employees including the BNS, rural Improvement Club, Barangay Agri-Fishery Council, Sangguniang Kabataan Officials, 4h Club and other Barangay-Based Institutions who shall assist in the operation and maintenance of the barangay community garden;

- f. Identify the areas where the barangay community garden shall be establish;
- g. Coordinate with the City Agriculture Office, Provincial Agriculture Office and Department of Agriculture for any available agricultural trainings, seminars and capacity building services as well as seeding materials and other agricultural equipment that would help in the operation of barangay community garden;
- h. Lead the promotion of barangay community garden to the constituents including its importance and benefits as well as the products produce by the barangay community garden;
- i. Keep a record of the over-all operations of the barangay community garden, such as type of seedlings, number of seedlings per plant planted, and number of vegetable and fruits harvested, either per piece, per kilo, among others;
- j. Ensure the adequate provision of agricultural services and facilities in the barangay community garden, pursuant to Sec. 17 of LGC of 1991;
- k. Establish group of volunteers in the barangay to help in the establishment of and maintenance of the barangay community garden as well as to spread the setting-up of backyard garden and planting of fruit-bearing tress.
- l. Submit report to the CLGOO about the barangay compliance to the DILG MC no. 2023-001 on the establishment of barangay community garden.

**SECTION 5. FUNDING.** An amount of Ten Thousand (10,000.00) Pesos is hereby allocated to the operationalization of the program chargeable to the Barangay MOOE and shall be funded regularly in compliance to EO 138 series of 2022 to ensure success of local autonomy.

**SECTION 6. IMPLEMENTATION.** The Barangay LGU shall strictly implement the policy guidelines under this ordinance.

**SECTION 7. SEPARABILITY CLAUSE.** If for reason any part or provision of this ordinance shall held invalid, other parts of the provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

**SECTION 8. REPEALING CLAUSE.** All previous ordinances and resolutions in conflict with the provision of this ordinance are hereby repealed, modified or amended accordingly.

**SECTION 9. EFFECTIVITY.** This ordinance shall take effect upon approval subject to posting requirements.





### **BARANGAY ORDINANCE NO. 21**

Series of 2024

**AN ORDINANCE PROVIDING CASH INCENTIVES TO ALL BARANGAY VOLUNTEER EMPLOYEES WHO OPTED TO RETIRE AT THE AGE OF 60 AND HAVE RENDERED A MINIMUM OF 10 STRAIGHT YEARS OF SERVICE TO THE BARANGAY**

**WHEREAS**, barangay volunteer employees are the frontliners in providing crucial social / medical services to the public;

**WHEREAS**, they are the first individuals exposed to risk associated with the maintenance and promotion of public health, peace and order and disaster management;

**WHEREAS**, despite the hazard they face and the inevitable rise in the cost of living, they remained true and committed in providing the best and upright service to the public;

**NOW THEREFORE**, on motion of Hon. Edmund P. Pancha, duly seconded by Hon. Maria A. Pasicolan, and subsequently approved by the body,

Be it ordained, by the Sangguniang Barangay in session assembled that:

**Section 1. TITLE** – For brevity, this ordinance shall be known as “Barangay Volunteer Employees Cash Incentive Ordinance.”

**Section 2. COVERAGE** – This ordinance covers all barangay volunteer employees / workers.

**Section 3. DEFINITION** –

1. Barangay Volunteer Employees/Workers - refers to the individuals, who have undergone basic training courses conducted by accredited government agencies or Non-Government Organizations (NGOs), and who voluntarily render primary social and medical services in the

barangay of Cataggaman Viejo. They include, among others, The Barangay Health Workers (BHWs), the Barangay Nutrition Scholars (BNS), and the Barangay Police (Tanods).

2. Ten (10) Years Of Service – means that the barangay volunteer employee/worker rendered a minimum of straight Ten (10) Years of cumulative or consecutive service even in the different positions for as long as these positions are recognized by the Sangguniang Barangay.

**SECTION 4. CASH INCENTIVE.** – Cash incentive in the amount of Five Thousand Pesos ( ₱5,000.00) for a minimum of 10 years of service be granted to a barangay volunteer employee/worker, who:

- Has reached at least the age of Sixty (60)
- Has rendered no less then 10 years of service in the barangay

A barangay volunteer employee/worker who has not fully complied with the prerequisite stated in the previous paragraph shall not be entitled to the said cash incentive.

**SECTION 5. FUNDING.** – The needed amount to be disbursed in connection with the benefit ordained in this ordinance shall be charged against the Gender and Development (GAD) Fund and/or any other available fund.

**SECTION 6. RETROACTIVITY.** – This ordinance is retroactive. Former barangay volunteer employee/worker who met the qualifications but retired before the enactment of this ordinance shall be covered and shall be entitled to the aforementioned cash incentive.


**SECTION 7. REPEALING CLAUSE.** – Any or all ordinances, rules and regulations, or provisions thereof which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY.** – This ordinance shall take effect upon approval.



ORDINANCE No. 22 - 2024

**AN ORDINANCE PROVIDING MEASURES FOR THE BEAUTIFICATION, DEVELOPMENT, MAINTENANCE AND MANAGEMENT OF THE BARANGAY ECO-PARK LOCATED AT CATAGGAMAN VIEJO, TUGUEGARAO CITY, CAGAYAN**

### EXPLANATORY NOTE

=====

The Barangay Cataggaman Viejo has now a BARANGAY ECO-PARK, or Eco-Park for short, located at Old Provincial Road, Gannaban Street Extension, facing the beautiful mighty Cagayan River, wherein people can rest, enjoy and relax together with their families or friends after a day of tedious activities at home or at work. As planned, it will soon be equipped with amenities for recreation especially for children, therefore it is important that the Sangguniang Barangay shall adopt a measure in order to ascertain that the eco-park is far from destruction and shall be utilized to the purpose it is established for.

### SECTION 1. DECLARATION OF POLICY.

- A) The Barangay Local Government Unit of Cataggaman Viejo recognizes that the Barangay Eco-Park serves as a venue for family recreation, as well as a place for community gathering, and as such, shall promulgate measures for their maximum benefit.
- B) The Barangay Local Government Unit of Cataggaman Viejo needs to improve the eco-park and provide measures for its beautification, development, maintenance and management.
- C) The concerned government institutions, non-government organizations, barangay-based institutions, Sangguniang Kabataan and other community organizations shall be encouraged to get involved in the beautification, development and maintenance of the eco-park.
- D) The barangay residents shall be called upon to assist in the beautification, development and maintenance of the eco-park.

SECTION 2. DEFINITION OF TERMS. In this ordinance, the following terms and phrases shall mean:

- A) Barangay Eco-Park – a public playground, public recreation center or area, established and maintained by the Barangay Local Government Unit of Cataggaman Viejo for the purpose of public rest, play recreation, enjoyment or assembly and all facilities and structures located thereon.
- B) Stalls or structures – a building, permanent, semi-permanent or temporary, erected or established within the boundaries of the Eco-Park.
- C) Vandalism – any defacement or destruction of the structure, or any act that willfully and negligently damages property. In this ordinance, vandalism shall also mean those undesirable acts like making graffiti, spray paint, cutting of flowers, or plants, and breaking of lighting bulbs, placing chewing gum on benches and other similar behaviors.


SECTION 3. REGULATED ACTS. The following acts shall constitute a violation of this ordinance to wit:

- A) Committing of any form of vandalism on the structures and facilities and amenities and various property improvements that include benches, tables, courts, its lighting system including landscapes or putting anything that tends to desecrate physical appearance.
- B) Putting of anything that will obstruct the beautiful view of the eco-park that includes, but not limited to any kind of structures, unauthorized streamers of buntings.
- C) Using the eco-park of holding any game of chance including Bingo Socials and raffle draws or operating videoke without permission from the Sangguniang Barangay.
- D) Performing or attempting to perform acts that tend to offend or violate public morals customs and culture.
- E) Defecating or urinating on playground structures within the eco-park.
- F) Destroying, cutting plants, or any plants or flora for landscaping and beautification of the eco-park without permission or causing acts that tend to destroy their original set-up.

SECTION 4. PROVISIONS. CONDITION IN THE USE OF THE BARANGAY ECO-PARK. The following shall govern the use of the Barangay Eco-Park:


- A) The Barangay Eco-Park shall be open to the public and a curfew hours shall be implemented from 9:00 PM to 4:00 AM for below eighteen (18) years of age, except for some special occasion or event that was approved by the Sangguniang Barangay. This is to ensure the safety and protection of eco-park users since said eco-park has a concrete sloppy structure and very near to the Cagayan River and that accident may happen at dark time or night time.
- B) The eco-park shall be kept free and clear for the use of the public and the same shall not be used or occupied for any purpose, whatsoever, other than that for leisure and recreation including group exercise, holding sports activities, meetings and others that has the approval of the Sangguniang Barangay.



**“AN ORDINANCE REGULATING THE USE AND OPERATION OF VIDEOKE, KARAOKE MACHINES AND OTHER SIMILAR AMPLIFIED AUDIO SOUND DEVICES WITHIN RESIDENTIAL AREAS AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES”**

**WHEREAS**, the Sangguniang Barangay through Section 16 of the Local Government Code of 1991 shall exercise the powers expressly granted, those necessary implied therefrom, as well as powers necessary, appropriate, incidental for the efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Article 25 of Republic Act No. 386, otherwise known as Civil Code Of The Philippines, states that, "Every person shall respect the dignity, personality, privacy and peace of mind of his neighbors and other persons.";

**WHEREAS**, the Sangguniang Barangay has been receiving many complaints from residents all over the barangay regarding loud videoke machines or other loud sound producing devices from their neighbors or establishments near them;

**WHEREAS**, the excessive, unnecessary or unusually loud sound from the said audio devices beyond the limit of acceptable level within residences is deemed as noise pollution and cause annoyances, disturbances, and injuries that endangers the comfort, health, peace and safety of other households, families and/or individuals;

**WHEREAS**, the Sangguniang Barangay recognizes the need to prescribe a systematic, organized and implementable mechanism to regulate the use of videoke/karaoke machine;

**NOW, THEREFOR**, on motion of Kagawad Santiago S. Addatu Jr, and seconded by all Kagawads present:

BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF BARANGAY CATAGGAMAN VIEJO, CITY OF TUGUEGARAO, PROVINCE OF CAGAYAN, IN ITS REGULAR SESSION ASSEMBLED:

**SECTION 1: TITLE** – This Ordinance shall be known as the “**BARANGAY CATAGGAMAN VIEJO VIDEOKE MACHINE REGULATION ORDINANCE**”;

**SECTION 2: DEFINITION OF TERMS.**

- a. **Video Karaoke Machine/Unit** – Any equipment or musical contrivance comprising of a television set or monitor, video player, amplifier, speakers, microphones and any sound system used for sing-along whereby lyrics of a song with accompanying visual backdrops are seen on a monitor or screen.
- b. **Noise Pollution** – also known as noise disturbance; is the disturbing or excessive noise level (more than 70 decibels) and that which can still be heard after a distance of at least 50 feet from the source.
- c. **Operators** – any individuals and/or business establishments within the Barangay that uses Videoke/Karaoke Machines and other Audio or sound Producing devices and/ or equipment;

**SECTION 3: ALLOWED HOURS FOR THE USE AND OPERATION OF VIDEOKE MACHINE AND OTHER SOUND SYSTEM; AND PROHIBITONS.**

- a. Operation of videoke/karaoke machines and other audio/sound system used by operators within or near Residential Areas are only allowed to operate their machines from 10AM but must minimize the volume as time reaches 10 o'clock in the evening then eventually stop the sound/ music at 12 midnight;
- b. Operation of Videoke/Karaoke machines and other audio/sound system used for personal purposes and not for business or income purposes within or near residential areas shall only be allowed to use such machines from 10AM to 10PM only;
- c. No person shall make, or cause any excessive, disturbing, unreasonable and unnecessary sound from videoke machine or other sound system such as karaoke, radio, television sets, amplified musical instrument, drums, loudspeaker, or other sound-producing device in such manner or with such volume so as to annoy the quiet and comfort of a reasonable person of normal sensitivities in any dwelling or residence; or with louder volume than is necessary for convenient hearing of the person who is in the place in which such device is operated, and near the places of worship during worship hours and near schools during school hours;

**SECTION 4. EXEMPTIONS.**

- a. Barangay sponsored activities and the like such as celebration of fiestas, etc.
- b. Existing businesses or establishments that are engaged in entertainment who shall provide effective soundproofing of their establishments to maintain the tolerable noise level outside their establishments shall be exempted from this Ordinance provided that no complaints will be received by the Barangay because of their operation;

- c. For personal occasions such as birthday celebrations, extensions of until 12:00 midnight may be granted by securing an extension permit from the office of the Punong Barangay. The applicant must fill out an application form provided by the Barangay and file it with the Barangay at least five working days before the actual date of the function. The form should include the following information: the nature of the intended activity, the type of audio device to be used, the specific location where the device will be used, and the period of time during which the device will be operated.
- d. Other Nationally commemorated occasions or celebrations such as Christmas and New year;

**SECTION 5. PENALTY.** – Any person or business operators found violating the provisions of this Ordinance shall be penalized as follows:

**a. For Non business Operators**

**a.1 First Offense** – Written/Verbal Warning;

**a.2 Second Offense** – Written Warning and a Fine of Five Hundred Pesos (Php500.00) and/or community service upon the discretion of the Punong Barangay including the days of Community service;

**a.3 Third and Succeeding Offense** – A fine of One thousand Pesos (Php1, 000.00) or file a complaint to City Trial court for proper disposition;

**b. For business operators**

**b.1 First Offense** – Written/Verbal Warning

**b.2 Second Offense** – a fine of One thousand Pesos (Php1, 000.00) and suspension of operation of five (5) days

**b.3 Third Offense** – a fine of One thousand Pesos (Php1, 000.00) and revocation of the business clearance to operate and endorsement to the Sangguniang Panglungsod for revocation of business permit to operate;

**SECTION 6. *Separability Clause.*** – If for any reason, any provision, section or part of this Code is declared not valid by a Court of competent jurisdiction or suspended or revoked by the Sangguniang Panglungsod, such judgment shall not affect or impair the remaining provisions, sections or parts thereof which shall remain or continue to be in full force and effect.

**SECTION 7. *Applicability Clause.*** – All other matters relating to the impositions in this Code shall be governed by pertinent provisions of existing laws and other ordinances.

**SECTION 8. *Repealing Clause.*** – All Ordinances, executive orders, rules and regulations or parts thereof, which are inconsistent with this Ordinance, are hereby repealed or modified accordingly.

**SECTION 9. *Effectivity and Transitory Clauses.*** – The effectivity of this Ordinance shall take effect upon approval.

**ENACTED UNANIMOUSLY** this 17th day of June, 2024 at the Barangay Hall, Barangay Cataggaman Viejo, City of Tuguegarao, Province of Cagayan.





### **Barangay Ordinance No. 24 Series of 2024**

#### **“AN ORDINANCE IMPLEMENTING THE TRAFFIC MANAGEMENT OF BARANGAY CATAGGAMAN VIEJO, CITY OF TUGUEGARAO, CAGAYAN”**

Sponsored by: **Kagawad SANTIAGO S. ADDATU JR**  
Co-Sponsored by: **All other Kagawads**

**WHEREAS**, the Sangguniang Barangay through Section 447 of the Local Government Code of 1991 and DILG Memorandum Circular No.2024-053 shall enact ordinances relative to barangay road clearing to regulate traffic on all streets and bridges for public welfare;

**WHEREAS**, the increase of vehicular traffic of the barangay thoroughfares, streets & alleys are further constricted by the wanton and indisciplined parking and/or stalling of vehicles along these roadways;

**WHEREAS**, the Sangguniang Barangay recognizes the need to prescribe a systematic, organized and implementable mechanism of maximizing the limited road space available to ensure the smooth flow of traffic;

**WHEREAS**, despite the existing ordinance of the city on illegal parking, the monitoring public still resort to parking vehicles wherever space is available regardless of its adverse effect on the flow of moving vehicular traffic;

**NOW, THEREFORE**, on motion of Kagawad Santiago S. Addatu Jr, and seconded by all Kagawads present:

**BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF BARANGAY CATAGGAMAN VIEJO, CITY OF TUGUEGARAO, PROVINCE OF CAGAYAN, IN ITS REGULAR SESSION ASSEMBLED:**

**SECTION 1. Title.** – This ordinance shall be known as the **“CATAGGAMAN VIEJO TRAFFIC ORDINANCE”**

**SECTION 2. Definition of Terms.** When used in this ordinance the following terms shall be defined:

2.1 **“BARANGAY CATAGGAMAN VIEJO TRAFFIC BRIGADE”** is the implementing body composed of Punong Barangay as Chairman, Committee on Transportation Head as Vice Chairman and Members of the Sanggunian and Deputized Barangay Public Safety Officer (TANOD) as members.

2.2 **“MOTOR VEHICLE”** shall mean any vehicle propelled by any power other than muscular power using the public highways, but excepting road rollers, trolley cars, street-sweepers, sprinklers, lawn mowers, bulldozers, graders, fork-lifts, amphibian trucks, and cranes if not used on public highways, vehicles which run only on rails or tracks, and tractors, trailers and traction engines of all kinds used exclusively for agricultural purposes.

Trailers having any number of wheels, when propelled or intended to be propelled by attachment to a motor vehicle, shall be classified as separate motor vehicle with no power rating.

2.3 **“GARAGE”** shall mean any building or structure in which a motor vehicle, either with or without driver, are kept.

2.4 **“PARKING OR PARKED”** shall mean that a motor vehicle is "parked" or "parking" if it has been brought to a stop on the shoulder or proper edge of a highway, and remains inactive in that place or close thereto for an appreciable period of time. A motor vehicle which properly stops merely to discharge a passenger or to take in a waiting passenger, or to load or unload a small quantity of freight with reasonable dispatch shall not be considered as "parked", if the motor vehicle again moves away without delay.

2.5 **“ONE-WAY TRAFFIC”** shall mean traffic that moves in a single direction.

2.6 **“ONE-WAY STREET”** shall mean a street facilitating only one way traffic directing motorized vehicles to move in one direction.

2.7 **“TRAFFIC FLOW”** shall mean movement of motorized vehicles between two points.

2.8 **“STALLED VEHICLES”** shall mean any motorized vehicle dilapidated/junk and/or its attachment which for any cause is unable to proceed under its own motive power and is on a public road, street or thoroughfare. An immobilize vehicle park on a certain space for a period of seven (7) days.

2.9 **“PARKING SPACE”** are designated places for parking of motor vehicles authorize d by the local government unit.

2.10 **“ILLEGAL PARKING/ILLEGALLY PARKED”** refers to one which is parked in areas prohibited by existing law or ordinance for parking purposes or those designated by the Authority and or the local government units (LGUs) as **NO PARKING** areas or zones.

2.11 **“ONE-SIDE PARKING”** shall mean a systematized conduct of parking in a particular street.

2.12 **“HEAVY EQUIPMENT”** shall mean any equipment traversing the road more than 5 tons (net weight) in weight and 5 meters length.

**Section 3. ONE-SIDE PARKING SPACE** – ONE-SIDE parking is allowed on one side of a one-way street provided that ample parking space is available for heavy/large vehicle to pass thru the said street. One side parking is observed on a designated street by the traffic management brigade.

**Section 4. PROHIBITED OBSTRUCTIONS** – Motor vehicle shall not allow to obstruct or otherwise park in front of any established road right-of-way, private or public driveways.

**Section 5. SPEED LIMIT**- A motor vehicle of any kind travelling any streets, roads and alleys within the barangay is limited to run at a maximum of twenty (20) kilometers per hour except on busy streets wherein a large number of vehicles pass through and regular traffic activity occur.

**Section 6. DESIGNATED PARKING AREAS**- No signs, barriers and/or other similar objects indicating “NO PARKING/RESERVED PARKING” shall be placed by any resident, association in any streets, roads & alleys. Only the Sangguniang Barangay is authorized to where to put up the signs indicating the same in the proper streets especially during special street occasions. In designing a parking area, preference shall be given to residents of the street. Business Establishment must secure a private parking lot for its customers.

**Section 7. NO ENTRY OF HEAVY EQUIPMENT**- No entry on all heavy equipment at school zone along Provincial roads on the following period:

6:45 Am–7:15 AM– Monday – Friday

11:00 Am–12:00 PM– Monday – Friday

4:00 Pm – 5:00 PM – Monday – Friday

**Section 8. DEPUTATION/ENFORCEMENT.** Devolving the objective of this ordinance the Barangay Council concerned and the Barangay Public Safety Officer are hereinafter deputized and directed to fully implement the provisions of the ordinance within their territorial jurisdiction. Only the City Traffic Management Group and the Barangay Deputized Traffic enforcer and members of the Sangguniang Barangay are hereby authorized and empowered to administer and implement all rules and regulations relative to this ordinance. All existing City ordinances related to Traffic Management are hereby ADOPTED.

### **Section 9. PENALTIES**

**FIRST OFFENSE**- Warning, a written/verbal notice will be issued to the offender by an authorized representative of Barangay Cataggaman Viejo Traffic Brigade.

**SECOND OFFENSE**- Issuance of City Official Violation receipt as provided under City Ordinance No. 47-08-2019(Adopting Road Safety of Tuguegarao City).

Stalled and/or illegally parked vehicles in violation of this Ordinance shall likewise be towed/impounded and a fine imposed on the driver or registered owner as provided under SP No. 47-08-2019.

**SECTION 10. Separability Clause.** – If for any reason, any provision, section or part of this Ordinance is declared not valid by a Court of competent jurisdiction or suspended or revoked by the Sangguniang Panglungsod, such judgment shall not affect or impair the remaining provisions, sections or parts thereof which shall remain or continue to be in full force and effect.

**SECTION 11. Applicability Clause.** – All other matters relating to the impositions in this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.



### ORDINANCE NO. 25 Series of 2024

#### **ADOPTING AN ORDINANCE PROHIBITING ANY ILLEGAL STRUCTURES AND OBSTRUCTIONS ON PUBLIC ROADS AND OTHER SIMILAR PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY CATAGGAMAN VIEJO, TUGUEGARAO CITY, CAGAYAN**

**WHEREAS**, the clearing of roads aims to remove obstructions and illegal obstructions that could help motorists to drive better and for pedestrian to find safe areas to walk on. Further, by reclaiming the streets, alleys and walkways, pedestrian will be encouraged to walk thereby promoting mobility and a healthy lifestyle. Conducting road clearing operations, establishment/placing street signages and street and make Local Government Units (LGUs) vibrant and more livable;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued various polices on road clearing operations, the latest are Memorandum Circular No. 2020-085 dated June 20, 2022 and MC No. 2023-017 dated January 25, 2023 which direct the LGUs to conduct road clearing operations and Barangay Road Clearing Operations (BaRCO) in the case of barangays and to undertake other initiatives to reclaim public roads which are being used for private ends and clearing;

**WHEREAS**, the above-cited Circulars clearly laid down the accountabilities and responsibilities of the LGUs from the provinces, cities and municipalities down to the barangays in the implementation of road clearing;

**WHEREAS**, on January 5, 2024, President Ferdinand R. Marcos, Jr. called on Local Government Units to start with order and cleanliness and pronounced that "Let our Barangays be the laboratory of workable ideas, a showcase of what we can achieve together, and proof that the basic government unit, the barangay teems with best practices. Simulan po natin sa kaayusan at kalinisan. Kaya kumilos tayo upang gawing maaliwalas at malinis ang kapaligiran. Dapat walang lugar at puwang and dumi, dugyot at dilim sa ating pamayanan."

**WHEREAS**, the President also urged the local officials, including the newly elected village and youth council officials to take the lead in clearing up all roads, canals, markets and schools.

**NOW, THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG BARANGAY OF CATAGGAMAN VIEJO, TUGUEGARAO CITY, CAGAYAN, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:**

**Section 1. Short Title** – This Ordinance shall be known and cited as the “Road Clearing Ordinance of Barangay Cataggaman Viejo”.

**Section 2. Coverage** – This Ordinance shall cover all kinds of obstructions on barangay roads and other public places within the territorial jurisdiction of Barangay Cataggaman Viejo of the Municipality of Tuguegarao City, Cagayan committed by individuals, entities, establishment and companies other than those obstructions committed by persons while driving or operating motor vehicles and all other forms of conveyances.

**Section 3. Definition of Terms** – as a general rule, words and phrases embodied in this ordinance not herein specifically defined shall have the same meaning as found in legal dictionaries as well as in existing laws. Provided that, the following terms as used in this ordinance, shall be construed to mean:

A. Obstruction – are structures, materials, whether permanent or temporary, movable or immovable or activities within the road right-of-way that impedes the free and clear passage of motor vehicles or pedestrian and/or pose danger or cause injury to motorists, pedestrians, or occupants of nearby structures;

B. Public Roads – means all streets, roads, bridges, highways and other thoroughfares constructed and maintained by the national government or by any local government unit;

C. Barangay Roads – refer to minor tertiary roads, streets, alleys under the management of the Barangay and other roads officially turned over to Barangays;

D. Road Right-of-way – means the legal access established by usage with precedence over others in a particular situation or place;

E. Sidewalk – means that portion of roadway assigned for the use by pedestrians, which must be free from all forms of physical obstructions or anything found on it, whether of value or not;

F. Sidewalk Vendor – means any person who sells or offers for sale any consumer products, whether agricultural or manufactured, cooked foods and/or dry goods, items or articles, including any person who attends to these products intended to be sold at any temporary location, sidewalk, alley vacant space or portion thereof; and

G. Street – means any open space established by eminent domain including the space above for access of vehicles and people, for the continuous flow of vehicular traffic and pedestrian;

**Section 4. Prohibition** – It is hereby prohibited and considered unlawful for any person or group of persons, entity, establishment to obstruct the free flow of people, goods and vehicles through the barangay road network within the territorial jurisdiction of Barangay Cataggaman Viejo by using, utilizing or otherwise appropriating any road, street, sidewalk, or pedestrian walkway, avenue, alley, bridge, park and other public place or portion thereof, for commercial or personal purposes. The prohibition includes all kinds of obstructions such as but not limited to:

4.1 Illegally parked vehicles including e-bike and e-tricycle along public roads, shoulders or sidewalks;

**Section 8. Exemptions** – For purposes of exempting an activity as an obstruction from the coverage of this ordinance, the following criteria shall be observed:

A. That it has proper coordination and duly approved by the barangay in which the duration of the activity is properly determined such as religious/community activities (preaching, processions or holding of a wake or other affairs of the community like birthday, fiesta celebration, games and amusement);

B. In cases of construction and repairs along public roads, equipment and materials used in such undertaking shall not be considered as obstructions under this ordinance, provided, that such undertaking has proper coordination with the appropriate government office and duly approved by the latter;

C. In cases where such obstructions are necessary incidents dictated by reasons of emergency to protect and save lives or properties from any calamity or public danger whether natural or man-made;

D. For one-way traffic rule, all emergency trip vehicles, and other vehicles which are to bring patients to have medical attention; and

E. Other cases when expressly permitted or allowed by law or an ordinance promulgated to meet a momentary necessity of order and public safety.

**Section 9. Declaration** – All obstructions and illegal structures, including those not specified by the foregoing section, are hereby declared as public nuisance and are subject of summary abatement.

**Section 10. Other Administrative Provisions**

10.1 Conduct of religious activities or the holding of wake or other community affairs like games/amusement activities should be coordinated with the Barangay Cataggaman Viejo concerned and the Local Police Station.

10.2 All items, goods and structures found on or along roads, streets, sidewalks, other public places and spaces within the jurisdiction of Barangay Cataggaman Viejo shall be confiscated by the barangay without prior notice.

10.3 Barangay Cataggaman Viejo shall not be held liable for any damage arising from the removal, confiscation, or disposal of all confiscated items.

**Section 11. Penalties** – Violators of this Ordinance shall be penalized as follows:

11.1 First Offense: Fine of Five Hundred Pesos

11.2 Second Offense: Fine of One Thousand Pesos

11.3 Third and Succeeding Offenses: Fine of Two Thousand Pesos and Imprisonment

of one (1) month, or both at the discretion of the Court.

**Section 12. Information and Education Campaign** – Information, education and communication (IEC) Materials for such awareness campaigns will be produced and disseminated by the barangay using all forms of media informing

**Section 13. Repealing Clause** – All ordinances and resolutions, or parts thereof, the provisions of which are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended and modified accordingly.

**Section 14. Separability Clause** – If for any reason or reasons, any provision of this ordinance be declared invalid, the other provisions not affected thereby shall remain in full force and effect.

**Section 15. Effectivity Clause** – This ordinance shall take effect immediately upon compliance of the posting requirement following its approval.





**WHEREAS**, Republic Act No. 7743, mandates the establishment of Barangay Reading Centers in order to promote the moral and intellectual well-being of the people, elevate the literacy level of every Filipino, and recognize the vital role of knowledge and information in nation-building;

**WHEREAS**, the 1987 Philippine Constitution provides that the State shall give priority to education, science and technology, arts culture, and sports to foster patriotism and nationalism, accelerate social progress, and total human liberation and development;

**WHEREAS**, this Sanggunian further deems it essential and imperative to modernize the Barangay Cataggaman Viejo Reading Center by making it more attuned to the latest technological advancement available in the digital information age;

**WHEREAS**, this Sanggunian finds it necessary the adoption of electronic library system in order to provide electronic and online resources to students in the barangay to enhance their educational development and provide educational resources for effective learning and research activities.

**NOW THEREFORE**, be it enacted by the Sangguniang Barangay of Cataggaman Viejo, Tuguegarao City that:

**Section 1. TITLE OF THE ORDINANCE.** This ordinance shall be known as “**Barangay Library and Internet Center Ordinance of Cataggaman Viejo**”.

**Section 2. ORGANIZATIONAL STRUCTURE.** The Barangay Cataggaman Viejo Library & Internet Center Board shall compose of the following:

**PUNONG BARANGAY**

Head, Barangay Library & Internet Center

**CHAIRMAN, COMMITTEE ON EDUCATION**

Asst. Head, Barangay Library & Internet Center

**Library & Internet Center BOARD**

**SK OFFICIAL**

(Librarian/Record Keeper)



### **Section 3. POWER AND FUNCTIONS OF THE PUNONG BARANGAY AS HEAD OF THE LIBRARY & INTERNET CENTER.**

The Punong Barangay shall undertake the following powers and functions as head of the barangay library:

- a. Exercise general management and control over all programs, projects, and activities of the Barangay Public Library;
- b. Directs the formulation of plans for the operations thereof with the consensus of the Board;
- c. Initiates and proposes policy measures for the effective governance of the Barangay Library from time to time;
- d. Exercise such other related powers and perform such other related duties as may be deemed necessary or appropriate towards the efficient and effective management of the Barangay Library.

**Section 4. POWER AND FUNCTIONS OF THE COMMITTEE CHAIRMAN OF EDUCATION AS ASSISTANT HEAD.** The Committee Chair on Education will assist in carrying out the different functions and programs of activities of the Punong Barangay enumerated in section 5;

### **Section 5. POWER AND FUNCTIONS OF THE SK OFFICIAL AS BARANGAYLIBRARIAN AND RECORD KEEPER.**

- a. Manages, supervises and oversees the effective, efficient and quality operation of the electronic library;
- b. Develops computer-assisted/computer-backed information systems which would permit online and network services;
- c. Establishes library system and procedures; disseminate information; render information, reference and research assistance; and educate users;

**Section 6. COMPOSITION OF THE BARANGAY LIBRARY BOARD.** The Barangay Cataggaman Viejo Library Board shall compose of the following:

Chairperson:	Punong Barangay
Vice Chairperson:	Committee Chair on Education
Secretariat:	Barangay Secretary
Members:	Barangay Officials Sanguniang Kabataan Officials School Representative

### **Section 7. POWER AND FUNCTIONS OF BARANGAY LIBRARY & INTERNET CENTER BOARD.**

The Barangay Cataggaman Viejo Library Board shall have the following powers and functions;

- a. To promulgate and determine policies for the effective and efficient operation and maintenance of the e-library;
- b. To serve as an advisory committee to the Sangguniang Barangay on Barangay library & internet center matters, such as but not limited to the necessity for the application of local appropriations for barangay library purposes;
- c. To provide recommendations and suggestions on the selection of library materials, library rules and regulations and other library problems;

**Section 8. SERVICES.** The following services shall be offered to Barangay Cataggaman Viejo constituents for free:

- a. Document Printing Services (Students Projects and Assignments);
- b. Document Encóding
- c. Online Research
- d. Reading Center
- e. Venue for Seminars & Training for the residents
- f. Venue for literary contest for youth development
- g. Cater the needs for online education for the residents
- h. Other Educational Related Activities


**Section 9. ALLOCATION OF FUND.** In the next ensuing fiscal year after this Ordinance shall have become effective, the Sangguniang Barangay shall cause the appropriations of funds from the General Fund or from private donors for the electronic library to efficiently and effectively carry out the provisions of this Ordinance, and to include therein all necessary operational or program support expenditures.


**Section 10. SEPARABILITY CLAUSE.** If only for any reason, any provision of this Ordinance is declared invalid or unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.

**Section 11. EFFECTIVITY.** This ordinance shall take effect upon the approval by the City Council and after posting of copies in the Barangay Hall and three (3) other conspicuous places in the Barangay, which occurs later.







**AMENDING BARANGAY REVENUE CODE NO. 08, SERIES OF 2020 IMPOSING TAXES ON BUSINESS ESTABLISHMENTS, BARANGAY CERTIFICATION AND CLEARANCES, DOCUMENTARY STAMP AND OTHER FEES AND CHARGES.**

**WHEREAS**, under Section 152 and 153 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the barangay may impose and collect such reasonable business taxes, fees and charges for services rendered;

**WHEREAS**, the Sangguniang Barangay amend the barangay revenue code no. 08, series of 2020 to update fees, tax and regulate businesses in the barangay;

**WHEREAS**, the Punong Barangay issues clearances and certifications from time to time which requires the continuing purchase of necessary bond paper and other supplies;

**NOW THEREFORE**, on motion duly seconded, it was,

**RESOLVED**, to enact the following:

Be it enacted by the Sangguniang Barangay, that:

## CHAPTER 1

### Article A. Title

**Section A. Title.** This ordinance shall be known as “**AN ORDINANCE AMENDING BARANGAY REVENUE CODE NO. 08, SERIES OF 2020 OF BARANGAY CATAGGAMAN VIEJO**”

### Article B. Definition of Terms

**Section B.** When used in this ordinance, the term:

**Business** – means trade or commercial activity regularly engaged in as a means of livelihood or with a view to profit.

**Capital** – signifies the actual state, whether in money or property owned by an individual or corporations; it is a fund with which it transacts its business, which would be liable to each creditor, and which in case of insolvency passes on to a receiver.

**Amusement** - is a pleasurable diversion and entertainment. It is synonymous to relaxation, avocation, pastime or fun.

**Amusement Places** – a place of amusement where one seeks admission to entertain oneself by seeing or viewing the show or performance.

**Charges** – refer to pecuniary liability, as rents or fees against persons or property.

**Fee** - means a charge fixed by law or ordinance for the regulation or inspection of a business or activity. It shall also include charges fixed by law or agency for the services of a public officer in the discharge of his official duties.

**Gross Sales or Receipts** – include the total amount of money or its equivalent representing the contract price, compensation or service fee, including the amount charged or materials supplied with the services and deposits or advance payments actually or constructively received during the taxable quarter for the services performed or to be performed for another person excluding discounts if determinable at the time of sales return, excise tax and value added tax (VAT).

**Person/s** – means every natural or juridical being, susceptible of rights and obligations or of being the subject of legal relations.

**Places of recreation** – include places of amusement where one seeks admission to entertain himself by seeing or viewing a show or performance or those where one amuses himself by direct participation.

**Residents** – refer to natural persons who have their habitual residence in this place, where they exercise their civil rights and fulfill their civil obligations, and to juridical persons for which the law or any other provisions creating or recognizing them fixes their residence in a particular province, city or municipality. In the absence of such law, juridical persons are residents of the province, city or municipality where they have their legal residence or principal place of business or where they conduct their principal business or occupation.

**Retail Stores** – are business establishments with fixed business address in the barangay where goods are kept for sale to purchase for personal consumption.

**Tax** – means an enforced contribution usually monetary in form, levied by the law-making body on person and property subject to its jurisdiction for the precise purpose of supporting governmental needs.

## CHAPTER 11. BUSINESS TAX

### Article C. Tax on Retail Stores or Retailers and other Business Establishment

**Section C. 1. Imposition of Tax** – There is hereby levied an annual tax of One percent (1%) of gross sales or receipts for the preceding calendar year of P50,000 (or less) on "stores or retailers with fixed business establishments.

e. Games & Amusement Centers	-	P400.00 per annum

g. Carenderia		
1. Permanent	-	P300.00 per annum
2. Seasonal	-	P 50.00 per stall
f. Videoke/Karaoke	-	P300.00 per annum
g. Farm Equipment for Rent	-	P300.00 per cropping
h. Building Permit	-	P300.00 per issuance
I. Billboards/Signs for Business/Professional	-	P100.00 per issuance
j. Other businesses(Talipapa)	-	P300.00 per annum

**Section C.2 Time of Payment and Collection of Tax** – The tax imposed herein shall accrue on the first day of January of each year. The tax must be paid to, and collected by the Barangay Treasurer before any business or trade activity can be lawfully begun.

### ARTICLE D. CLEARANCE OR CERTIFICATION FEE

**Section D.1 Imposition of Fee.** There shall be collection for the issuance of clearance or certification by the Punong Barangay or his duly authorized representative in case of leave of absence or official travel, the following fees:

a. Barangay Clearance for any Business or Activity for purpose of securing Mayor's Permit	P 100.00
b. Certification for purposes of securing housing or multipurpose loan, calamity/emergency loan from private/government institutions	P 100.00
c. Certification for Business Engagement Outsiders	P 100.00
d. Certification of Ownership for outgoing livestock	P 200.00
e. Any other clearance or certification other than those above-mentioned	P 50.00

**Section D.2 Exemption.** No fee shall be collected for the issuance of a certification of indigency or when it is officially requested by any court or government agency.

**Section D.3 Time of Payment.** The fees imposed shall be paid to the Barangay Treasurer at the time of the request is granted or before the request is granted.

**Section D.4 Administrative Provision.** Issuance of a Barangay Clearance for any business or trade activity located or conducted within the territorial jurisdiction of this barangay as a requirement before Mayor issues a license or permit, shall be acted upon within seven (7) days from filing.

In the event that a clearance is not issued within the said period, the Mayor may then issue the corresponding license or permit being applied for by the applicant.

## ARTICLE E. "LUPON" FILING FEE

**Section E.1 Imposition of Fee.** There is hereby imposed a filing fee for any dispute brought before the Lupon Tagapamayapa of this barangay subject for amicable settlement, conciliation or arbitration by the Lupon Tagapamayapa at the following rates:

**Section E.2 Time and Manner of Payment.** The fee imposed herein shall be paid to the Barangay Treasurer at the time of the filing of the complaint. The Barangay Treasurer shall issue the necessary receipt therefore.

## CHAPTER IV. GENERAL ADMINISTRATIVE PROVISIONS

### Article F. COLLECTION AND ACCOUNTING OF BARANGAY TAXES AND OTHER IMPOSITIONS

**Section F.1 Record of Persons Paying Revenue.** It shall be the duty of the Barangay Treasurer to keep a record, alphabetically arranged and open to public inspection during office hours, of the names of all persons paying barangay taxes, fees and charges. He shall, as far as practicable, establish and keep current the appropriate tax roll for each kind of tax, fee or charge provided in this Ordinance.

**Section F.2 Accounting of Collections.** Unless otherwise provided in this Ordinance and other existing laws and ordinances, all monies collected by virtue of this Ordinance shall be accounted for in accordance with the provisions of existing laws, rules and regulations and credited to the General Fund of the Barangay.

The forms and the guidelines to be observed for the proper and effective implementation of this Section shall be those prescribed by the Department of Finance.

**Section F.3 Accrual to the General Fund of Fines, Costs, and Forfeitures.** Unless otherwise provided by law or ordinance; fines collected for violation of this ordinance shall accrue to the General Fund of the barangay.

**Section F.4 Automatic Adjustment of Fees.** Fees collected by the Barangay Treasurer shall be automatically increased at the rate of ten percent (10%) every five (5) years.

## CHAPTER V FINAL PROVISIONS

### ARTICLE G. MISCELLANEOUS PROVISIONS

**Section 1.1 Separability Clause.** If for any reason, any provision, section part of this ordinance is declared not valid by the Court of competent jurisdiction or suspended or revoked by the Sangguniang Panglungsod, such judgement shall not affect or impair the remaining provisions, sections, or parts thereof which shall remain or continue to be in full force and effect.

**Section 1.2 Applicability Clause.** All other matters relating to the impositions in this ordinance shall be governed by pertinent provisions of existing laws and other ordinances.

**Section 1.3 Repealing Clause.** All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this ordinance, are hereby repealed, amended or modified accordingly.

**Section 1.4 Review of Barangay Ordinance.** Within ten (10) days after its enactment, the sangguniang barangay shall furnish copies of all barangay ordinances to the sangguniang panlungsod for review as to whether it is consistent with law and city ordinances. If the sangguniang panlungsod failed to take action on barangay ordinance within thirty (30) days from receipt thereof, the same shall be deemed approved.


**Section 1.5 Effectivity.** The enacted ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board in front of the barangay hall or in any two (2) conspicuous places in the barangay. The Barangay Secretary shall cause the posting of the concerned ordinance in two (2) conspicuous places not later than five (5) days upon approval thereof.





#### IV. OPEN FORUM

1. Mrs. Elicia Calimag raised concerns about boarders staying in boarding houses during the day but leaving at night without paying. Sangguniang Barangay Member Edmund P. Pancha suggested profiling both boarders and boarding house owners.
2. Operators of reapers and seeders entering the barangay to do business should be charged per crop season.
3. A ₱50 certificate fee will be charged to complainant/s whose case/s remain unresolved at the Lupong Tagapamayapa level.
4. Sangguniang Barangay Member Santiago S. Addatu Jr. informed that the City Government will assess substandard buildings like the Barangay Hall.
5. Punong Barangay Gil C. Tumbali suggested retrofitting the barangay Multi-Purpose Hall through a bank loan.
6. Easement of any should maintain a 1.5-meter distance from the road.
7. Additional information by Sangguniang Barangay Member, Santiago S. Addatu Jr. Barangay Disaster Risk Reduction Management (BDRRM) Committee, Chaired by Ferdinand B. Bassig plans to buy a rescue vehicle and necessary equipment.
8. Additional information by Sangguniang Barangay Member, Santiago S. Addatu Jr. about the plan of the Committee on Barangay Disaster Risk Reduction Management (BDRRM) to purchase a rescue vehicle and other necessary equipment.
9. Sitio Areg should be classified as part of the Cabauatan Street extension.
10. Information by Sangguniang Barangay Member, Santiago S. Addatu Jr. that his wife Mrs. Corazon B. Addatu is offering her services to assist children with behavioral disorders, without an age limit.
11. Sangguniang Barangay Member Ferdinand B. Bassig, Chair of the BDRRM Committee, confirmed the completion of two drainage systems in Sitio Areg (Cabauatan Street extension) and Atal Street, including the portion in front of Cataggaman Elementary School project of City Government.
