



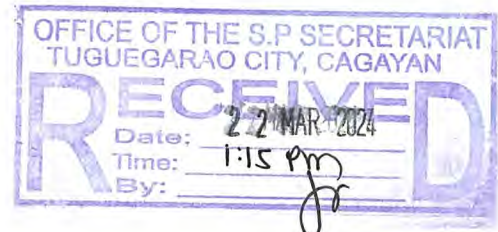

Ordinance 01-2024

An Ordinance adopting the City Ordinance No. 13-2002 re: Prohibiting the use of streets, alleys, road right of ways, and open public spaces for drinking liquor and other intoxicating beverages

WHEREAS, To refrain from any untowards incidents to the residents of Barangay Leonarda, there is a need to prohibit the drinking of liquor and other intoxicating beverages in public places as cited above;

WHEREAS, There are times that the passers-by are forced to drink against their will by persons drinking liquor in public places;

NOW THEREFORE, it is hereby ORDAINED to adopt the City Ordinance No.13-2002 to read as follows;

SECTION I: Title.

This Ordinance shall be known as " AN ORDINANCE PROHIBITING THE USE OF ALLEYS, ROAD RIGHT OF WAYS, PARKS AND OPEN PUBLIC SPACES FOR DRINKING AND OTHER INTOXICATING BEVERAGES"

SECTION II: Terms and Conditions

a. It shall be unlawful to drink liquor, intoxicating beverages along streets, alleys, road right of ways, and open public spaces

SECTION III: Penal Provisions

Any person caught in violation of this Ordinance shall be penalized as follows;

First Offense- a fine of 200.00 shall be imposed

Second Offense- a fine of 300.00 shall be imposed

Third and Fourth Offense- a fine of 500.00 shall be imposed and or to render community service for 1 week.

The Barangay Leonarda Officials shall be deputized to implement the Ordinance and the collection of penalties will be in favor of the Barangay;


SECTION IV; Repealing Clause

Any Ordinances, resolutions or issuances inconsistent herewith are hereby modified, amend or repealed accordingly

SECTION V: Effectivity


This Ordinance shall take effect immediately upon approval on motions of all Sangguniang Barangay members present was unanimously approved.
