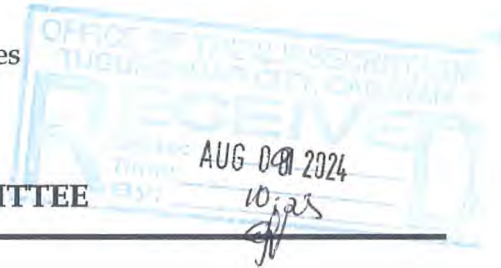


Ladies and Gentlemen:



Ladies and Gentlemen:


Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Annual Budget for CY 2024 of Barangay Annafunan West** in the amount of **Five Hundred Forty Five Thousand Pesos (P 545,000.00)** approved through **SK Resolution No. 4-2024** on June 7, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.

In view thereof, SK funds shall be utilized and disbursed in conformance with DBM-DILG-NYC Joint Memorandum Circular (JMC) No. 1-2019 dated January 23, 2019 and Local Budget Circular No. 148 dated December 23, 2022.
