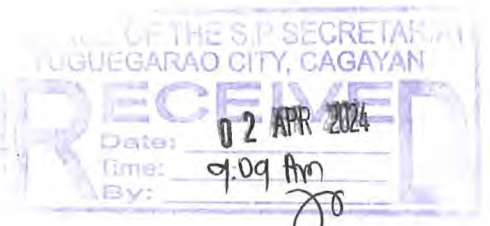

## MEMORANDUM OF AGREEMENT

### KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA) is made and entered into this \_\_\_\_\_ at \_\_\_\_\_, Philippines by and between:

The **LOCAL GOVERNMENT UNIT (LGU) - OF \_\_\_\_\_**, through the Municipal/ City Anti-Drug Abuse Council (CADAC), represented herein by its **City Mayor / CADAC Chairperson, \_\_\_\_\_**, hereafter referred to as the "**FIRST PARTY**";

-and-

The **CAGAYAN VALLEY MEDICAL CENTER**, a government institution duly recognized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at Maharlika Highway, Carig Norte, Tuguegarao City, Cagayan represented by its Medical Center Chief of Hospital II, **GLENN MATTHEW BAGGAO, MD**, herein referred to as the "**SECOND PARTY**";

### WITNESSETH:

**WHEREAS**, Department Memorandum No. 2021-0512 otherwise known as the Interim Guidelines for the Certification of Community Based Drug Rehabilitation Program, Local Government Units (LGUs), as the implementers to Community-Based Drug Rehabilitation Program (CBDRP), established and operated their local programs by implementing different models depending on available resources in the community.

**WHEREAS**, to standardize the implementation of the Community-Based Drug Rehabilitation Program (CBDRP) and assure quality services provided to Persons Who Use Drugs (PWUDs) in the community, the **FIRST PARTY** desires to engage the medical and clinical services of the **SECOND PARTY**.

**WHEREAS**, the **SECOND PARTY** is willing to accept the same under such conditions hereunder stipulated.

**NOW, THEREFORE**, in consideration of the foregoing premises, the parties do hereby mutually and jointly agree to the following terms and conditions:

#### **Section 1. Roles and responsibilities of the FIRST PARTY:**

1. Facilitate the pertinent referral documents for those PWUDs classified as high risk for drug dependency and/or with substance use disorder.
2. Coordinate with concerned Physician as to the medical status of PWUDs.
3. Ensure that hospital bills, if any, was settled by the PWUDs.

**Section 2. Roles and responsibilities of the SECOND PARTY:**

1. Provide clinical and medical assistance, care, and examinations (check-ups), which may include Complete Blood Count, Urinalysis, Fasting Blood Sugar, Physical Examination services and other health services.
2. Provide necessary certifications and outpatient consultation to PWUDs.
3. Ensure that appropriate safety procedures are in place.
4. Undertakes to comply with all the health and medical standards, rules, and regulations as well as applicable governing provisions of the law, regulations, and/ or ordinances, now in force or to be affected hereafter.

**PARTIES FURTHER AGREE THAT:**

- A. The Memorandum of Agreement shall not be amended or modified without the consent of the contracting parties.
- B. This Agreement shall take effect immediately upon signing hereof and shall remain in force and in effect until revoked, modified, or amended accordingly.

In view of the foregoing covenants, the parties hereto mutually bind themselves the full responsibility and accountability to the stipulated conditions contained herein.
