Ladies and Gentlemen:

Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the Sangguniang Kabataan Annual Budget for CY 2025 of Barangay Ugac Norte in the amount of One Million Three Hundred Thirty Six Thousand Two Hundred Pesos (P 1,336,200.00) approved through SK Resolution No. 2-2025 on January 18, 2025 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.
