ORDER FOR THE RESPONDENT

You are hereby required to submit your verified answer to the complaint of Ms. Romilie L. Mora et. al within fifteen (15) days from receipt thereof pursuant to the following provisions:

Section 62 of the Local Government Code on Notice of Hearing which states that:

"Within seven days after the administrative complaint is filed, the sanggunian concerned shall require the respondent to submit his verified answer within fifteen days from receipt thereof, and commence the investigation of the case within ten days after receipt of such answer of the respondent."

Section 4 of Ordinance No. 19-2000 "An Ordinance Providing for the Rules and Regulations in the Investigation, Hearing and Disposition of Administrative Cases Against Elective Barangay Officials" which states that:

"The City Council Secretariat shall record and assign a docket number to the complaint, notifies and requires the respondent within five days after the administrative case is filed, to submit a verified answer within 15 days from receipt thereof."

"Failure of the respondent to file the verified answer within fifteen days from receipt of the complaint shall be considered a waiver to present evidence in his behalf. Within ten days after the receipt of the verified answer, the Committee shall commence to hear and investigate the case."

Your failure to submit a verified answer is deemed a waiver on your part and your case shall be disposed upon based on the available records.

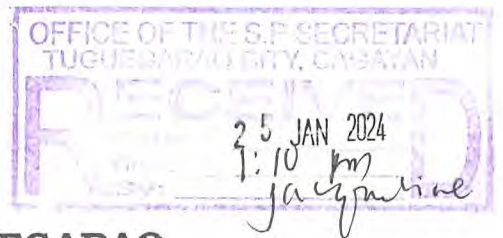

JOINT COMPLAINT-AFFIDAVIT

We, ROMILIE L. MORA, single, of legal age, Filipino Brgy. Secretary of Linao West, Tuguegarao City, **FLORENCIA M. QUIZZAGAN**, married, of legal age, Filipino, Brgy. Nutrition Scholar of Linao West, Tuguegarao City, and **REGINA Q. BAQUIRAN**, married, of legal age, Filipino, Brgy. Health Worker of Linao West, Tuguegarao City, and all residents of Linao West, Tuguegarao City, Cagayan, sworn in accordance with law, hereby depose and states that:

1. That we are incumbent Barangay Staff/Workers of the Barangay Local Government Unit of Brgy. Linao West, Tuguegarao City duly appointed in accordance with law.
2. That we would like to file an administrative complaint against **MARLON A. GUIYAB**, a duly elected member of Sangguniang Barangay of Linao West, Tuguegarao City, Cagayan, for Gross Misconduct, Abuse of Authority and Conduct Prejudicial to the Best Interest of the Service for unlawfully having committed grave offenses which undermine the pillars of public service.
3. I, **ROMILIE MORA**, hereby state that on January 11, 2024 at around 12:45 in the afternoon at the Barangay Hall of Linao West, Tuguegarao City, Respondent Marlon Guiyab arrived at the brgy. Hall and threatened me with a short firearm and thereafter pointed

at me and then discharged the same firearm at a nearby chair inside the office.

4. Kagawad Guiyab went to the office purposely to received and deliver the cash advance requested by the fifteen (15) members of Barangay Tanod, after having counted, he ordered me to call Punong Barangay (PB) Ricky Quilang and asked why the amount was Seventeen Thousand Pesos (P17,000.00) whereas there are only 15 members of brgy. tanod who were asking for P1,000.00 each as cash advance. At this juncture, I have observed from his words, movements and expressions that he is under the influence of liquor aside from his reddish face and breath with a smell of alcohol drink.

5. As such, I decided to call PB Quilang and asked why the amount of cash advance is P17,000.00. PB Quilang answered that the additional P2,000.00 was intended as cash advance of the Brgy. Electrician and one (1) Tanod who was not included in the payroll. Afterwhich, I handed the said amount of money to Kagawad Quilang;

6. That while I was writing down the names of the members of brgy. Tanod in a piece of bond paper, I saw Kagawad Guiyab pulled out a short firearm, pointed at me and said in Itawes “**Sec. kannang ku ubak mu**”, which means, “Sec. I will shoot your butt”, he was then standing near at my right side;

7. That I just ignored the same knowing that he is intoxicated and that he might be fooling around but I was shocked when he pulled the trigger shooting at a chair at my back. I was frightened by such event. It was my first time to experience an actual firing of a gun and it almost hit me;

8. After few minutes, PB Quilang arrived. Upon noticing the arrival of the PB, Kagawad Guiyab again pointed closely his gun to me and said in Itawes, “ **Nedanug mu yakan, kaam i-blotter nak?**, which means “ Did you report me, why are you trying to file a written complaint?”

9. At that point, I saw Kagawad Guiyab immediately removed the magazine of the handgun and put it inside his pocket. He was also rushing home carrying the chair and said he will just make the repair in their house;

10. The due to this incident, I suffered mental anguish, fright, serious anxiety, besmirched reputation, wounded feelings, moral shock, social humiliation, and similar injury.

11. We, **FLORENCIA M. QUIZZAGAN** and **REGINA BAQUIRAN**, hereby state that on January 11, 2024, 12:40 PM while we are at the Brgy. Health Center situated at the ground floor the Brgy. Hall in Linao West, Tuguegarao City, we saw Barangay Kagawad Marlon A. Guiyab arriving at the Brgy. Hall of Linao Norte, Tuguegarao City, alighted from a tricycle and loading magazine on a handgun colored silver/black he was holding, after which, he tucked it on his waist. When Kagawad Guiyab saw us, he asked the whereabouts of PB Quilang and we answered that the PB is not in his office and it was only the Secretary who was at the second floor. Right then and there we observed that he was under the influence of intoxicating drink.

12. When Kagawad Guiyab went upstairs, I, **FLORENCIA QUIZZAGAN** immediately sent a chat through messenger to my sister, **ROMILIE MORA** to inform that Kagawad Guiyab is armed with a gun specially that she was alone;

13. At about 12:45 PM, we heard a gunshot coming from the second floor particularly at the office of PB Quilang;

14. That I, **FLORENCIA QUIZZAGAN**, called PB Quilang through phone and I said in Itawes, “Kap. Nakapalattug I Marlon kang utun inka pay innan ta baka napalatturanna I Secretary ta mesissa nakannay” which means “Kap., Marlon can you please see Marlon because he fired his gun, maybe the Secretary was shot, she is alone there”;

15. After few minutes, PB Quilang arrived at the barangay hall with Chief Tanod Nicolas Balisi, immediately he ordered Balisi to proceed upstairs to check what happened. When went down, Balisi reported that he met Kagawad Guiyab while rushing downstairs carrying a chair and went away from the barangay hall;

16. That when we went up at the second floor to see Brgy. Secretary **ROMILIE MORA**, we smell gunpowder with traces of smoke;

17. That I **REGINA QUILANG**, said to PB Quilang in Tagalog” Insan, kabastusan na yung ginawa ni pare Marlon sayo, wala ng galang sayo, nagpapatok pa ng baril sa loob ng office mo”, which means “Cousin, Marlon is so rude to you, he pays no respect to you, he fired his gun even inside your office”.

18. That I, **FLORENCIA QUIZZAGAN** requested PB Quilang to report the incident to the police and ask for assistance but he did not do. As such, I took the initiative to call for the police. Minutes thereafter, two (2) policemen arrived, asked us what transpired and

recommended us to proceed to the police station to formally report the unfortunate incident;

19. That I **FLORENCIA QUIZZAGAN**, went to the PNP Regional Office 02 to request for firearm verification upon the person of Marlon Guiyab Y Alan, resident of Alan St., Linao West, Tuguegarao City, Cagayan and that based on the initial firearms record verification result, he has no license to own and possess firearms. However, he is a licensed/registered firearm holder of one(1) AKKAR Shotgun KARATAY TAKTIK 12GA with Serial No. 10204828 which has expired on November 1, 2015.

Attached herein are Sworn Statement of ROMILIE MORA, marked as "Annex A", Joint Sworn Statement of FRORENCIA QUIZZAGAN and REGINA BAQUIRAN, marked as "Annex B", Certification of Police Blotter Report, marked as "Annex C", Certification from the PNP re-registration of firearms, marked as "Annex D", Request for Firearms Verification and Initial Firearms Record Verification Result, marked as Annex E1 and E2, respectively;

20. From the foregoing, Kagawad Guiyab committed the following administrative offenses, to wit:

A. **Grave abuse of authority** as he used or misused his authority as a duly elected brgy. official in a wantonly and capriciously excessive or extravagant manner contrary to the natural or legal rules for its use. The Court in Office of the Ombudsman v. Caberoy, defined oppression or grave abuse of authority as "a misdemeanor committed by a public officer, who under color of his office, wrongfully inflict upon any person any bodily harm, imprisonment or other injury. It is an act of cruelty, severity, or excessive use of authority. The act of Kagawad Guiyab of threatening and discharging firearms which almost hit Bgry. Sec. Mora is well within the meaning of grave abuse of authority which must never be tolerated.

B. **Gross misconduct** as defined is the transgression of some established and definite rule of action, more particularly, unlawful behavior or gross negligence by a public officer coupled with the elements of corruption, willful intent to violate the law or to disregard established rules. Attending usual chores as public servant under the influence of liquor and discharging of firearm inside an office is patently transgression of established rules in public offices. Moreso, that the gun used is unlicensed.

C. **Conduct Prejudicial to the Best Interest of the Service** is a highly improper act, deficient in prudence, discretion and judgment that tends to undermine people's faith and confidence in the government. It need not be connected with the performance of duty. All the improprieties committed by Kagawad Guiyab January 11, 2024, entering office while intoxicated, illegal discharged of firearms, threatening a staff and inflicting psychological harm which results to serious impact on a person's mental health and disregarding the sanctity of public office are conducts Prejudicial to the Best Interest of the Service.


21. Clearly, Kagawad Guiyab committed all those improprieties levelled against his person as duly elected public official and as such, we jointly pray for his **DISMISSAL IN SERVICE** as Barangay Kagawad of Linao West, Tuguegarao City and to **PERPETUALLY DISQUALIFY HIM FROM HOLDING PUBLIC OFFICE**. His acts are highly improper, possessing criminal tendencies, deficient in prudence, discretion and judgment that tends to undermine our faith and confidence to duly elected officials like Kagawad Guiyab.

22. That we are executing this affidavit to formally file an administrative complaint against **Sangguniang Barangay Member MARLON GUIYAB for Gross Misconduct, Grave Abuse of Authority and Conduct Prejudicial to the Best Interest of the Service**.

23. That we are willing to narrate other matters relevant hereto if necessary.



Romilie Mora y Labang, 30 years old, single and a barangay secretary; Florencia Quizzagan y Mora, 40 years old, married and a barangay nutrition scholar; and Regina Baquiran y Quilang, 49 years old, married and a barangay health worker all residents of Alan St., Linao West, Tuguegarao City, Cagayan appeared before this office and requested to put into record Alarm and Scandal (Illegal Discharge of Firearm) and Grave Threat committed at about 12:45 PM of January 11, 2024 at the Barangay Hall of Linao West, Tuguegarao City, Cagayan while the suspect was identified as Marlon Guiyab y Alan barangay Kagawad of Linao West, Tuguegarao City, Cagayan.

Upon receipt of the incident, immediately personnel of this office responded to conduct investigation and possible arrest of the suspect utilizing D-MAX mobile car driven by Pat. Mamba. However, upon arrival thereat, the suspect was already not at their house and can no longer be located. Further initial investigation conducted shows, according to Romilie Mora while she was alone inside the office of the barangay chairman as a duty barangay secretary, the suspect seemingly under the influence of intoxication beverages came inside purposely to give the money that was being instructed to him by Barangay Captain Ricky Quilang. Subsequently, the suspect asked her why Barangay Captain Quilang gave him Seventeen Thousand Pesos (₱17,000.00) wherein they were only 15 tanod members. From There, the suspect told him to call for Barangay Captain Quilang and clarify why he gave him Seventeen Thousand Pesos wherein they were only 15 tanod members. There and then, Barangay Captain Quilang answered the Two Thousand Pesos (₱2,000.00) was for Barangay electrician and the other barangay tanod that was not included in the payroll. Thereafter, the suspect gave the said money to Romilie Mora which is amounting to Seventeen Thousand Pesos as cash advance of the Barangay Tanods and from there, they counted and checked the amount of the money. Subsequently, the suspect drew a silver/black pistol on his left waist and pointed at the back of the victim while she was sitting which was glanced and seen by Romilie Mora while the suspect was standing on her right side. There, the suspect uttered the word to wit "**Sec kannang ku ubak mu**". Moment later, suspect fired the said pistol hitting the wooden chair to where she was seated. Moment later, Barangay Chairman Quilang arrived and there, the suspect suddenly uttered the word to wit "**Naidanug mu yakan kanni Kap, Anni Yan, Kaam ta iblotter nak?**" while the suspect was holding and pointing the gun on her. Thereafter, the suspect gets the wooden chair and the fired empty shell who immediately left the said place of incident. With the said incident, it caused her to be threatened.

Furthermore, according to Florencia Quizzagan and Regina Baquiran, prior to the incident, the suspect arrived at the Barangay Hall of Linao West on board in his tricycle and while in his tricycle, they saw the suspect loading the magazine with ammunitions and after it, he inserted it in a pistol firearm. After which, he tucked it on his waist. And proceeded at the second floor of the Barangay Hall building. Moment later, they heard a gun burst causing them to be alarmed and worried that bad and unpleasant things happened. After which, the suspect went out the building, carrying with him a wooden chair and fled away.

Moreover, said police officers together with barangay Captain Ricky Quilang and the victims proceeded at the house of the parents of the suspect wherein we were able to recover the evidence (wooden chair).
