

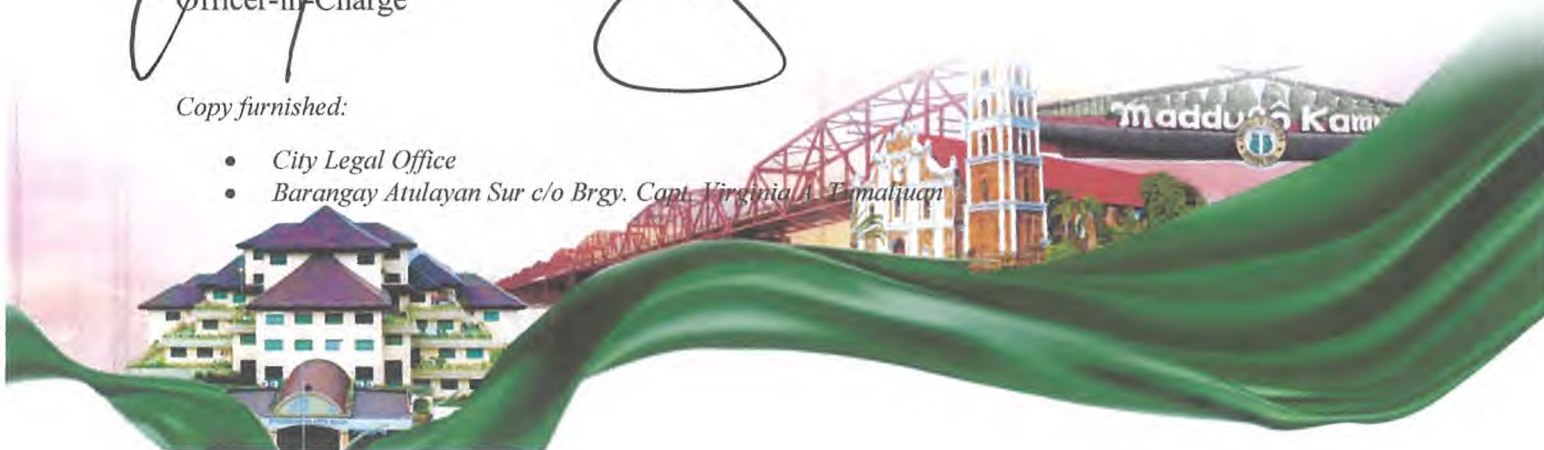

Dear *Hon. Mayor Ting-Que*:

Greetings! I do hope this letter finds you well and in good health.

This has reference to the request forwarded to the City Legal Office for comment regarding the proposed conduct of an amusement activity or "perya" in Barangay Atulayan Sur in celebration of its patronal feast, which will be held on September 10, 2025 until October 15, 2025.

Upon review of the documents submitted in support of the request and upon consultation with the Business Permit and Licensing Office (BPLO), it appears that the proponent has substantially complied with the documentary requirements, which include the following:

1. A formal **Request Letter** from the proponent barangay and the owner/operator of the amusement or "peryahan";
2. A duly executed **Memorandum of Agreement (MOA)** between the Punong Barangay and the owner; and
3. A **Barangay Resolution** authorizing the conduct of the perya within the specified period and a **Barangay Resolution** authorizing the Punong Barangay to enter and negotiate into a Memorandum of Agreement with the owner and operator of the amusement or "peryahan".

In view of the foregoing, and absent any legal impediment at this stage, this Office finds no legal objection to the proposed activity, subject to compliance with all applicable laws,






TERMS & CONDITIONS


It is mutually understood and agreed by and between the parties that:

1. The "perya" shall be establish within the barangay grounds for the period September 10 To October 15, 2025 in celebration for the Patronal Feast;
2. The proprietor MS. MARIE JOY C. SIDDAYAO shall pay a total amount of Twenty-Five Thousand Pesos (P25,000.00) to Barangay Atulayan Sur, Tuguegarao City as fee within the agree period which will be used for the celebration activities of the barangay;
3. Barangay Atulayan Sur shall ensure the safety and security of the "perya" operators while operating within the barangay;
4. The Perya operators shall ensure peace and order in the barangay and prevent any illegal and prohibited activities while operating for the said period;
5. This MOA may be amended from time to time by mutual agreement of the parties in a written modification signed by both parties;
6. This MOA may be terminated by mutual agreement of the parties, and shall Automatically terminate upon completion of all responsibilities as stated herein, unless otherwise amended.
