

Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Annual Budget for CY 2025 of Barangay Linao West** involving an appropriation of **Four Million Three Hundred Forty Eight Thousand Five Hundred Fifty Pesos (P 4,348,550.00)** approved by the Sangguniang Barangay on January 10, 2025 with **Appropriation Ordinance No. 1-2025** shows substantial compliance with the budgetary requirements and general limitations set forth in the code, other provisions of law and its implementing rules and regulations.




Ladies and Gentlemen:

Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Annual Budget for CY 2025 of Barangay Cataggaman Nuevo** in the amount of **One Million Three Hundred Thirty Thousand Pesos (P 1,330,000.00)** approved through **SK Resolution No. 2-2025** on January 25, 2025 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.


