## CITY ORDINANCE NO. 01-09-2025

## CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF PORTION OF CORNER BONIFACIO STREET FROM CORNER GONZAGA STREET AND CORNER LUNA STREET, TUGUEGARAO CITY, CAGAYAN ON JANUARY 26, 2025 (HALF LANE FROM 2PM ONWARDS) TO JANUARY 27, 2025 - 6AM TO 12NN (HALF LANE 1PM ONWARDS) TO PAVE WAY FOR THE LUNAR NEW YEAR FESTIVITIES

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, the Lunar New Year is an occasion being celebrated in solidarity with Chinese lineage;

**WHEREAS**, the by virtue of Proclamation No. 727, the Office of the President has declared January 29, 2025 as special non-working day throughout the entire country;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, endorsed to the Ninth City Council requesting for the temporary closure of portion of Bonifacio Street from corner Gonzaga Street and corner Luna Street to pave way for the festivities of the occasion and to avoid traffic and road congestion;

**WHEREAS**, the Ninth City Council in its 122<sup>nd</sup> Regular Session found the request to be proper and with merit, hence, recommended for its approval.

**NOW**, **THEREFORE**, be it **ORDAINED** by the Ninth City Council in session assembled to enact the following Ordinance:

Section 1. Title. This Ordinance Shall Be Known As "City Ordinance Declaring the Temporary Closure of Portion of Corner Bonifacio Street From Corner Gonzaga Street and Corner Luna Street,



Tuguegarao City, Cagayan on January 26, 2025 (Half Lane From 2PM Onwards) to January 27, 2025 – 6AM to 12NN (Half Lane 1PM Onwards) to Pave Way for the Lunar New Year Festivities."

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover Bonifacio Street from corner Gonzaga Street and corner Luna Street as subject for closure to give way to the said activity.

**SECTION 3. INFORMATION**. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City.

**SECTION 4. IMPLEMENTATION**. The implementing agency shall be the Public Safety and Security Unit (PSSU), Traffic Management Group and the concerned barangay/s along the affected streets.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on January 26-27, 2025.
