#### CITY ORDINANCE NO. 03-10-2025

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF BONIFACIO STREET FROM CORNER WASHINGTON STREET TO GOMEZ STREET FOR THE DRUM AND GLOCK AND TUGSAYAW COMPETITION BLOCKINGS/REHEARSALS ON JULY 31, 2025 TO AUGUST 05, 2025

IN CONNECTION WITH THE CELEBRATION OF THE 301st PAVVURULUN AFI FESTIVAL

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Tuguegarao City will be celebrating its 301st Patronal Feast of Tuguegarao City in honor of its Patron Saint, San Jacinto de Polonia, on August 7 to August 16, 2025;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the temporary road closure of Bonifacio Street in view of the Drum and Glock and Tugsayaw Competition blockings/rehearsals in celebration of this year's 301st Patronal Feast;

WHEREAS, the Traffic and Rerouting Plan aims to establish a parking management system and smooth flow of traffic during the activity, provide safety, security and control measure, and traffic monitoring and assistance;

**WHEREAS**, the Tenth City Council in its 4<sup>th</sup> Regular Session held on July 22, 2025, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval;

**NOW**, **THEREFORE**, be it **ORDAINED**, by the Tenth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF BONIFACIO STREET FROM CORNER WASHINGTON STREET TO GOMEZ STREET FOR THE DRUM AND GLOCK AND TUGSAYAW COMPETITION BLOCKINGS/REHEARSALS ON JULY 31, 2025 TO AUGUST 05, 2025 IN CONNECTION WITH THE CELEBRATION OF THE 301st PAVVURULUN AFI FESTIVAL."

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover the following streets on specified dates:

- a. Drum and Glock
  - July 31, 2025 (Thursday) 8:00AM to 2:00PM
  - August 01, 2025 (Friday) 8:00AM to 2:00PM
- b. Tugsayaw
  - August 02, 2025 (Saturday) 9:00-11:00AM and 6:30-9:30PM
  - August 03, 2025 (Sunday) 6:30-9:30PM
  - August 4, 2025 (Monday) 9:00-11:00AM and 6:30-9:30PM
  - August 5, 2025 (Tuesday) 9:00-11:00AM and 6:30-9:30PM

**SECTION 3. INFORMATION.** This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

**SECTION 4. IMPLEMENTATION.** This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on July 31, 2025 to August 05, 2025.
