CITY ORDINANCE NO. 03-09-2024

ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF BONIFACIO STREET CORNER GONZAGA STREET TO PAVE WAY FOR THE FESTIVITIES OF THE 2024 LUNAR NEW YEAR CELEBRATION ON FEBRUARY 8, 2024 FROM 8:00 AM TO 12:00 NN

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, the Lunar New Year will be celebrated on February 9, 2024 in solidarity with our brethren in the City with Chinese lineage;

WHEREAS, festivities for the said occasion will be held at Bonifacio Street corner Gonzaga Street particularly from Hotel Delfino to RCBC Bank on February 8, 2024 from 8:00 AM to 12:00 NN.

WHEREAS, the City Council has identified a portion of Gomez Street from Gomez-Bonifacio Street Intersection going to Gomez-Taft Street Intersection to be temporarily closed to pave way for the celebration of the 2024 Lunar New Year in the City.

NOW, THEREFORE, be it **ORDAINED** by the Ninth City Council of Tuguegarao in session assembled, to enact:

SECTION 1. TITLE. This Ordinance shall be known as *“An Ordinance Declaring the Temporary Road Closure of Bonifacio Street Corner Gonzaga Street to Pave Way for the Festivities of the 2024 Lunar New Year Celebration on February 8, 2024 from 8:00 AM to 12:00 NN.”*

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover a portion of Bonifacio Street Corner Gomez Street, particularly from Hotel Delfino to RCBC in front of the Tuguegarao City Commercial Center, as subject for closure to pave way for the festivities during the celebration of the 2024 Lunar New Year on February 8, 2024 from 8:00 AM to 12:00 NN.


SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages by the Public Safety and Security Unit (PSSU)/Traffic Management Group (TMG) and by the City Public Information Office, all mass media outlets and officials of Barangay Centro 07, Tuguegarao City.

SECTION 4. IMPLEMENTATION. The implementing office shall be the PSSU/TMG. Installation of signages and implementation of alternate routes shall be implemented.


SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval for the duration specified herein.
