CITY ORDINANCE NO. 04-10-2025

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF A PORTION OF OLD PROVINCIAL ROAD (BOULEVARD), PARTICULARLY IN I LOVE TUGUEGARAO CITY PARK IN CELEBRATION OF THE 3rd TAGGAM FESTIVAL ON AUGUST 1, 2 AND 7, 2025

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Barangay Cataggaman Nuevo will be holding its 3rd Taggam Festival to celebrate community culture, creativity and unity;

WHEREAS, in line with the said celebration, Barangay Cataggaman Nuevo has requested for the temporary closure of a portion of the Old Provincial Road (Boulevard) particularly in the area covering the "I Love Tuguegarao City Park", which will serve as the official venue for major events;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Tenth City Council the request of Barangay Cataggaman Nuevo for the temporary closure of the said portion of the road;

WHEREAS, the temporary closure of this portion of the road is necessary to ensure public safety, facilitate smooth program execution and accommodate festival goers and participants;

WHEREAS, the Tenth City Council in its 5th Regular Session held on July 30, 2025, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval;

NOW, **THEREFORE**, be it **ORDAINED**, by the Tenth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF A PORTION OF OLD PROVINCIAL ROAD (BOULEVARD), PARTICULARLY IN I LOVE TUGUEGARAO CITY PARK IN CELEBRATION OF THE 3rd TAGGAM FESTIVAL ON AUGUST 1, 2 AND 7, 2025."

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover the following streets on specified dates:

- a. August 1-2, 2025 preparation and conduct of the Opening Program of the 3rd Taggam Festival
- b. August 7, 2025 Super Sireyna Queen Cataggaman Nuevo 2025 Pageant Night

SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

SECTION 4. IMPLEMENTATION. This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police and other barangay/s concerned along the affected roads.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on August 1-2, 2025 and August 7, 2025.
