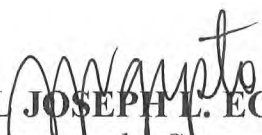

CITY ORDINANCE NO. 07-10-2025

**CITY ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 01-10-2025
DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC
AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE CONDUCT OF
VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE
301ST PATRONAL FEAST OF TUGUEGARAO CITY TO MOVE THE TEMPORARY
CLOSURE OF DESIGNATED ROADS FOR THE TUGSAYAW (STREET
DANCE COMPETITION) FROM AUGUST 09, 2025 TO AUGUST 16, 2025, 5:00 PM
ONWARDS AND AUGUST 17, 2025, 4:00 AM TO 12 MN**

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Tuguegarao City will be celebrating its 301st Patronal Feast of Tuguegarao City in honor of its Patron Saint, San Jacinto de Polonia, on August 7 to August 16, 2025;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the amendment of Section 2 of City Ordinance No. 01-10-2025 on the temporary road closures for the Tugsayaw (Street Dance) from August 09, 2025 to August 17, 2025 to align with the rescheduled date of the parade proper in celebration of this year's 301st Patronal Feast;

NOW, THEREFORE, be it **ORDAINED**, by the Tenth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "**CITY ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 01-10-2025 DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE**

CONDUCT OF VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE 301st PATRONAL FEAST OF TUGUEGARAO CITY TO MOVE THE TEMPORARY CLOSURE OF DESIGNATED ROADS FOR THE TUGSAYAW (STREET DANCE COMPETITION) FROM AUGUST 09, 2025 TO AUGUST 16, 2025, 5:00 PM ONWARDS AND AUGUST 17, 2025, 4:00 AM TO 12 MN.”

SECTION 2. SCOPE AND LIMITATION. Section 2 of Ordinance No. 01-10-2025 on Tugsayaw (Street Dance Competition) only shall be amended as follows:

FROM:

August 9, 2025 (12:00 NN-12:00 MN) – TUGSAYAW (STREET DANCE COMPETITION)

- 1. Temporary closure of Bonifacio Street from corner College Avenue to Aguinaldo Street.
- 2. Temporary closure of Washington Street from corner Blumentritt Street to Del Rosario Street.
- 3. Two-Way Traffic flow of Rizal Street from corner College Avenue to Washington Street.

TO:

August 16, 2025 (5:00 PM ONWARDS) – TUGSAYAW (STREET DANCE COMPETITION)

- 1. Temporary closure of Bonifacio Street from Gonzaga Street (Delfino) to Gomez Street (RCBC)
Purpose: Facility Set-up (stage and others)

August 17, 2025 (4:00 AM to 12 MN) – TUGSAYAW (STREET DANCE COMPETITION)

- 1. Temporary closure of Bonifacio Street from corner Legaspi Street to Aguinaldo Street.
- 2. Temporary closure of Blumentritt Street from Legaspi Street to Aguinaldo Street.
- 3. Temporary closure of Burgos Street from Gonzaga Street to Luna Street.

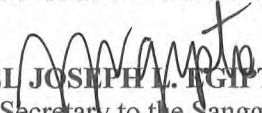
SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

SECTION 4. IMPLEMENTATION. This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on August 16, 2025, 5:00 PM onwards and August 17, 2025, 4:00 AM to 12MN.
