CITY ORDINANCE NO. 07-09-2024

ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF BONIFACIO STREET FROM CORNER WASHINGTON STREET TO CORNER LUNA STREET (FROM SECURITY BANK TO HOTEL ROMA) FOR THE WOMEN’S MONTH MOB DANCE (BABBAY-LE) ON MARCH 12, 2024 FROM 3:00 PM TO 10:00 PM

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Proclamation No. 227, s. 1988, “Providing for the observance of the Month of March as ‘Women’s Role in History Month’, emphasizes the role of Filipino women in the social, cultural, economic and political development throughout Philippine history. It provided for a month-long nationwide observance with appropriate ceremonies and activities to be spearheaded by the Commission.;

WHEREAS, the City Government of Tuguegarao joins the 2024 National Women's Month Celebration, with the sub-theme, "Lipunang Patas sa Bagong Pilipinas: Kakayahan ng Kababaihan, Patutunayan!";

WHEREAS, one of the festivities for the said occasion which is the Mob Dance will be held at Bonifacio Street from corner Washington Street to corner Luna Street (from Security Bank to Hotel Roma) on March 12, 2024 from 3:00 PM to 10:00 PM;

WHEREAS, City Mayor, Hon. Maila Rosario S. Ting-Que, requested for the closure of the said street for the celebration of the Women's Month.

NOW, THEREFORE, be it **ORDAINED** by the Ninth City Council of Tuguegarao in session assembled, to enact:

SECTION 1. TITLE. This Ordinance shall be known as *“Ordinance Declaring the Temporary Road Closure of Bonifacio Street from corner Washington Street to corner Luna Street (from Security*

Bank to Hotel Roma) for the Women's Month Mob Dance (Babbay-Le) on March 12, 2024 from 3:00 PM to 10:00 PM"

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover a portion of Bonifacio Street from corner Washington Street to corner Luna Street (from Security Bank to Hotel Roma) as subject for closure to pave way for the festivities during the celebration of the 2024 National Women's Month Celebration on March 12, 2024 from 3:00 PM to 10:00 PM.


SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages by the Public Safety and Security Unit (PSSU)/Traffic Management Group (TMG) and by the City Public Information Office, all mass media outlets and officials of Barangay Centro 07, Tuguegarao City.

SECTION 4. IMPLEMENTATION. The implementing office shall be the PSSU/TMG. Installation of signages and implementation of alternate routes shall be implemented.


SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval for the duration specified herein.
