
**Madam:**

**CITY ORDINANCE NO. 11-09-2024**

**CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF PORTION OF MAGGAY STREET BETWEEN DICIANO STREET AND ST. STEPHEN STREET, CATAGGAMAN NUEVO, TUGUEGARAO CITY, CAGAYAN ON MARCH 27-31, 2024 FROM 6:00 AM TO 6:00 PM FOR THE CONDUCT OF THE ANNUAL YOUTH CAMP OF THE CHURCH OF THE LIVING GOD**

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

**WHEREAS**, the Church of the Living God will conduct its Annual Youth Camp on March 27-31, 2024;

**WHEREAS**, the said activity will be participated by thousands of young people from the CLG Churches all over the country;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, endorsed to the Ninth City Council the request of the Punong Barangay of Cataggaman Nuevo, Hon. Waldo L. Zingapan, for the temporary closure of portion of Maggay Street, Diciano Street to St. Stephen Street, Cataggaman Nuevo to cater participants' transportation and to avoid traffic and road congestion;

**WHEREAS**, the Ninth City Council in its 84<sup>th</sup> Regular Session found the request to be proper and with merit, hence, recommended for its approval.

**NOW, THEREFORE**, be it **ORDAINED** by the Ninth City Council in session assembled to enact the following Ordinance:

**SECTION 1. TITLE.** This Ordinance shall be known as "*City Ordinance Declaring the Temporary Closure of Portion of Maggay Street between Diciano Street and St. Stephen Street,*

*Cataggaman Nuevo, Tuguegarao City, Cagayan on March 27-31, 2024 from 6:00 AM to 6:00 PM for the Conduct of the Annual Youth Camp of the Church of the Living God.”*

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover Maggay Street between Diciano Street and St. Stephen Street, Cataggaman Nuevo as subject for closure to give way to the said activity.

**SECTION 3. INFORMATION.** This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City.

**SECTION 4. IMPLEMENTATION.** The implementing agency shall be the Public Safety and Security Unit (PSSU), Traffic Management Group and the concerned barangay along the affected streets.


**SECTION 5. EFFECTIVITY.** This Ordinance shall take effect on March 27-31, 2024.
