**CITY ORDINANCE NO. 11-09-2025**

**CITY ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF BONIFACIO  
STREET, FROM CORNER GONZAGA STREET TO GOMEZ STREET, ON  
MARCH 8, 2025 FROM 01:00 PM TO 11:00 PM FOR THE CONDUCT OF THE  
WOMEN'S DAY CELEBRATION**

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

**WHEREAS**, Proclamation No. 227, s. 1988, "Providing for the Observance of the Month of March as "Women's Role in History Month", emphasizes the role of Filipino women in social, cultural, economic, and political development throughout Philippine history. It provides for a month-long nationwide observance with appropriate ceremonies and activities to be spearheaded by the Commission;

**WHEREAS**, Tuguegarao City joins the celebration of Women's Month and will conduct an activity on March 8, 2025 to celebrate Women's Day.

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the 9th City Council a letter from the Public Safety and Security Office/Traffic Management Group (PSSO/TMG) Head, Mr. Arthur T. Blaquera, requesting for the temporary road closure of Bonifacio Street, from corner Gonzaga Street to corner Gomez Street, on March 8, 2025 for the conduct of the Women's Day Celebration activity;

**WHEREAS**, the proposed temporary road closure and rerouting plan will facilitate smooth traffic during the activities, and provide safety and security, and traffic assistance in the City;

**WHEREAS**, the City Government recognizes that it can resume enforcement of regular traffic flow in the City as soon as the activity is completed, to prevent further disruption of the usual traffic flow of the riding public;



**WHEREAS**, the Ninth City Council in its 128<sup>th</sup> Regular Session held on March 3, 2025, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval.

**NOW, THEREFORE**, be it **ORDAINED**, by the Ninth City Council in session assembled to enact the following:

**SECTION 1. TITLE.** This Ordinance shall be known as ***“CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF BONIFACIO STREET, FROM CORNER GONZAGA STREET TO CORNER GOMEZ STREET, ON MARCH 8, 2025 FROM 01:00 PM TO 11:00 PM FOR THE CELEBRATION OF WOMEN’S DAY 2025.”***

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover a portion of Bonifacio Street, from corner Gonzaga Street to corner Gomez Street, on March 8, 2025 from 01:00 PM to 11:00 PM.

**SECTION 3. INFORMATION.** This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

**SECTION 4. IMPLEMENTATION.** This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.



Further, pursuant to Committee Report No. 75-2025, the PSSU/TMG shall assign personnel to manage the flow of traffic during the parade, and early information dissemination about the parade and subject road closures and temporary two-way traffic schemes, and the deployment of a standby rescue team during the said activity shall be done.

**SECTION 5. REPEALING CLAUSE.** Ordinances, executive orders and other local legislations inconsistent with this Ordinance are hereby modified or repealed accordingly.


**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect on March 8, 2025 from 01:00 PM to 11:00 PM.
