**CITY ORDINANCE NO. 14-10-2025**

**AN ORDINANCE REROUTING THE FLOW OF TRAFFIC FOR UNDAS 2025**

**WHEREAS**, All Saints' Day, celebrated annually on November 1, is a solemn holy day of the Catholic Church dedicated to all the saints, while All Souls' Day, observed on November 2, is devoted to praying for the faithful departed;

**WHEREAS**, as observed every year and as a part of Filipino traditions, there shall be a number of persons who shall go to cemeteries during the abovementioned days which shall cause traffic, among other things;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "local government units are authorized to exercise powers necessary, appropriate or incidental for their efficient and effective governance and those which are essential to the promotion of general welfare";

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Tenth City Council the proposed traffic and rerouting plan devised by the Public Order and Safety Office (POSO)/Traffic Management Group (TMG) for UNDAS 2025 for information and appropriate action;

**WHEREAS**, the PSSO/TMG and CDRRMO reported that the temporary traffic scheme implemented last year proved effective in managing traffic flow during UNDAS;

**WHEREAS**, considering the effectiveness of the previous traffic scheme, the same shall be adopted and implemented for this year;

**WHEREAS**, the Tenth City Council during its 16<sup>th</sup> Regular Session held on October 21, 2025 deemed it necessary to approve the proposed traffic scheme and enact an Ordinance implementing the proposed traffic and rerouting plan;

**NOW, THEREFORE**, be it **ORDAINED** by the Tenth City Council duly assembled in session to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as *AN ORDINANCE REROUTING THE FLOW OF TRAFFIC FOR UNDAS 2025*.

**SECTION 2. REROUTING.** The following streets shall be subject to rerouting and shall be implemented to their fullest extent to ensure an orderly and peaceful observance of All Saints’ Day and All Souls’ Day or UNDAS 2025:

**2.1 ONE-WAY TRAFFIC FLOW**

- a. Pengue Highway from Rotonda to Sunkist Street
- b. San Roque Street from Corner Pengue Highway (Petron) to Diversion Road (Aga’s Lechon)
- c. Sunkist Street from Corner Pengue Highway (Citimall) to Santol Street
- d. Santol Street from Corner San Roque Street to Sunkist Street
- e. Cabalza Street from Corner Santol Street to Taguinod Street (ISAP)

**SECTION 3. IMPLEMENTATION.** The Office of the City Mayor through the Public Order and Safety Office (POSO)/Traffic Management Group (TMG) shall implement the provisions of this ordinance in coordination with Philippine National Police, Civil Society Organizations and concerned Punong Barangays.

**SECTION 4. INFORMATION DISSEMINATION.** The City Information Office shall cause the widest dissemination of this Ordinance upon its approval. Signages shall be also installed.



**SECTION 5. LIABILITIES.** Those who will violate the traffic and rerouting plan shall be dealt with in accordance to the applicable provisions of City Ordinance No. 09-2017 *Adopting the New Traffic Rules and Regulations of Tuguegarao City*, as amended.


**SECTION 6. SEPARABILITY CLAUSE.** If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall remain in full force and effect.


**SECTION 7. REPEALING CLAUSE.** All Ordinances and administrative regulations or parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

**SECTION 8. EFFECTIVITY.** This Ordinance shall take effect upon its approval until November 2, 2025.
