### CITY ORDINANCE NO. 15-10-2025

ORDINANCE AUTHORIZING THE CITY VICE MAYOR, HON. ROSAURO RODRIGO G. RESUELLO, TO SIGN FOR AND ON BEHALF OF THE VICE MAYOR'S OFFICE AND SANGGUNIANG PANLUNGSOD OF TUGUEGARAO CITY, THE MEMORANDUM OF AGREEMENT WITH RBC CABLE MASTER SYSTEM REGARDING THE RENEWAL AND CONTINUED COVERAGE OF REGULAR AND SPECIAL SESSIONS

WHEREAS, Section 7, Article III of the 1987 Constitution states that right of the people to information on matters of public concern shall be recognized. Access to official records and to documents, and papers pertaining to official acts, transactions, or decisions, as well as to government research data used as basis for policy development, shall be afforded the citizen subject to such limitations as may be provided by law;

WHEREAS, RBC Cable Master System is a popular cable system in the province and has enough competence, efficiency and technical capacity to reach as far as the remotest Barangays of the City;

WHEREAS, RBC Cable Master System has been a steadfast partner of the Tuguegarao City Government committed to supporting its initiatives through effective and consistent information dissemination;

WHEREAS, a weekly television program may be utilized as a means of disseminating information on the various activities, programs and projects of the Office of the City Vice Mayor and the Sangguniang Panlungsod of the City to keep the public in touch and abreast with the said programs and activities and to gather public support and promote the image of the City Government;

WHEREAS, its coverage and replay of the City Council's Regular and Special Sessions in its community channel have played a vital role in keeping citizens informed about the important resolutions and ordinances enacted by the Council;

WHEREAS, this initiative for continued coverage of the Regular and Special Sessions will further strengthen public awareness of key legislative matters and ensure that constituents remain engaged and updated on developmental issues and concerns;

**NOW, THEREFORE,** be it **ORDAINED** by the Sangguniang Panlungsod. in session assembled, to enact;

SECTION 1. TITLE. This Ordinance shall be known as "AN ORDINANCE AUTHORIZING THE CITY VICE MAYOR, HON. ROSAURO RODRIGO G. RESUELLO, TO SIGN FOR AND ON BEHALF OF THE VICE MAYOR'S OFFICE AND SANGGUNIANG PANLUNGSOD OF TUGUEGARAO CITY, THE MEMORANDUM OF AGREEMENT WITH RBC CABLE MASTER SYSTEM REGARDING THE RENEWAL AND CONTINUED COVERAGE OF REGULAR AND SPECIAL SESSIONS."

**SECTION 2. PURPOSE.** The coverage of the sessions shall ensure transparency and accountability and wider public access to the legislative proceedings of the Sangguniang Panlungsod in the furtherance of the constitutional right of the people to information on matters of public concern.

**SECTION 3. AUTHORITY.** Pursuant to SECTION 456. Powers. Duties and *Compensation.* – (a) The city vice-mayor shall:

- e. Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

SECTION 4. SCOPE OF AUTHORITY. The authority granted under this Ordinance shall cover:

- a. Negotiation and execution of the contract with the RBC Cable Master System;
- b. Coordination with RBC Cable on the schedule, technical requirements and terms of broadcast;
- c. Ensuring that the contract terms are most advantageous to the government and compliant with all applicable procurement, accounting, and auditing laws, rules, and regulations.

**SECTION 5. APPROPRIATION.** The necessary funds for the implementation of this Ordinance shall be charged against the approved budget of the Sangguniang Panlungsod, subject to existing accounting and auditing rules and regulations.

**SECTION 6. SEPARABILITY CLAUSE.** If, for any reason, any part or provision of this Code shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 7. REPEALING CLAUSE.** All ordinances and administrative regulations, or part or parts thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval and shall be enforceable retroactively as of July 1, 2025.
