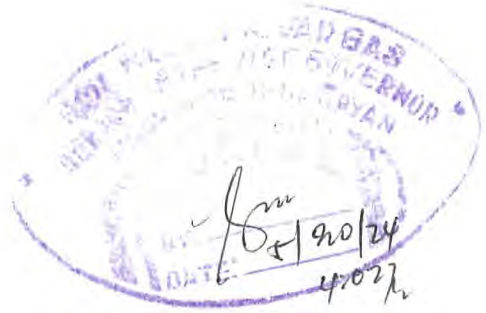



CITY ORDINANCE NO. 16-09-2024

CITY ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF HALF OF PROVINCIAL ROAD OF PALLUA NORTE (WAY TO BAGAY) FOR THE PASSIRIMMU FESTIVAL ON MAY 15, 2024 FROM 5:00 PM UNTIL 12:00 MN

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Barangay Pallua Norte will be celebrating its Passirimmu Festival on May 15-16, 2024, bringing together residents and visitors alike to celebrate the culture, heritage and traditions;

WHEREAS, the Sangguniang Kabataan and Barangay Council of Pallua Norte have requested for the temporary road closure of the Provincial Road (Way to Bagay) for the Passirimmu Festival on May 15, 2024 from 5:00 PM to 12:00 MN for the said event;

WHEREAS, to ensure the safety and enjoyment of all participants, there is a need for the temporary road closure of the said street to pave way for the Passirimmu Festival.

NOW, THEREFORE, be it **ORDAINED** by the Ninth City Council of Tuguegarao in session assembled, to enact:

SECTION 1. TITLE. This ordinance shall be known as the ***CITY ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF HALF OF PROVINCIAL ROAD OF PALLUA NORTE (WAY TO BAGAY) FOR THE PASSIRIMMU FESTIVAL ON MAY 15, 2024 FROM 5:00 PM UNTIL 12:00 MN.***

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover the Provincial Road of Pallua Norte (Way to Bagay) as subject for closure to pave way for the Passirimmu Festival on May 15, 2024 from 5:00 PM to 12:00 MN.




SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages by the affected barangay.

SECTION 4. IMPLEMENTATION. The implementing agency shall be the Public Safety and Security Unit (PSSU), Traffic Management Group in coordination with the Barangay Council of Pallua Norte.


SECTION 5. EFFECTIVITY. This ordinance shall take effect on May 15, 2024 from 5:00 PM to 12 MN.


CITY ORDINANCE NO. 16-09-2024

**CITY ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE
OF HALF OF PROVINCIAL ROAD OF PALLUA NORTE (WAY TO
BAGAY) FOR THE PASSIRIMMU FESTIVAL ON MAY 15, 2024
FROM 5:00 PM UNTIL 12:00 MN**

This City Ordinance was forwarded to the Office of the City Mayor on May 15, 2023 and was returned **UNSIGNED** on May 29, 2024. Relative to this, Section 54(b) of the Local Government Code states that:

“SECTION 54. Approval of Ordinances. - (a) Every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the local chief executive concerned approves the same, he shall affix his signature on each and every page thereof; otherwise, he shall veto it and return the same with his objections to the Sanggunian, which may proceed to reconsider the same. The Sanggunian concerned may override the veto of the local chief executive by two-thirds (2/3) vote of all its members, thereby making the ordinance or resolution effective for all legal intents and purposes.

*(b) The veto shall be communicated by the local chief executive concerned to the Sanggunian within fifteen (15) days in the case of a province, and **ten (10) days in the case of a city or a municipality; otherwise, the ordinance shall be deemed approved as if he had signed it.**”*
