

**CITY ORDINANCE NO. 18-09-2024**

**AN ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF BONIFACIO STREET FROM CORNER GONZAGA STREET TO GOMEZ STREET ON JUNE 15, 2024 FROM 4:00 PM TO 10:00 PM FOR THE CONDUCT OF THE PRIDE MONTH PARADE 2024**

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

**WHEREAS**, June is internationally recognized as Pride Month to honor the history, achievements and contributions of the LGBTQ+ community and to promote awareness and support for LGBTQ+ rights;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, sent a letter to the City Council requesting for the temporary closure of identified routes on June 15, 2024 for the conduct of the Pride Month Parade in the City;

**WHEREAS**, the participants of the Pride Parade will assemble at the Tuguegarao City Commercial Center for a short program after the parade;

**WHEREAS**, the Committee on Public Safety and Order and Disaster preparedness has identified Bonifacio Street from corner Gonzaga Street to corner Gomez Street to be temporarily closed in view of the Pride Month activities on June 15, 2024;

**WHEREAS**, there is a need to temporarily close the affected road in order to ensure public safety and smooth traffic flow.

**NOW, THEREFORE**, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Ninth City Council in Tuguegarao City, in session duly assembled, to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as “*An Ordinance Declaring the Temporary Road Closure of Bonifacio Street from Corner Gonzaga Street to Gomez Street on June 15, 2024 from 4:00 PM to 10:00 PM for the Conduct of the Pride Parade 2024.*”

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover Bonifacio Street from corner Gonzaga Street to corner Gomez Street as subject for temporary closure to pave way for the Pride Month Parade 2024.


**SECTION 3. INFORMATION.** This Ordinance shall be disseminated through signages and by the City Public Information Office and all mass media outlets in Tuguegarao City.

**SECTION 4. IMPLEMENTATION.** The implementing agency shall be the Public Safety and Security Unit (PSSU), Traffic Management Group.


**SECTION 5. Effectivity.** This Ordinance shall take effect from 4:00 PM to 10:00 PM on June 15, 2024.
