

# CITY ORDINANCE NO. 18-09-2025

AN ORDINANCE GRANTING LEGISLATIVE FRANCHISE TO VARGAS SPORTS COLISEUM TO OPERATE A COCKPIT IN BARANGAY PENGUE-RUYU, TUGUEGARAO CITY FOR A PERIOD OF THREE (3) YEARS, SUBJECT TO STRICT COMPLIANCE WITH THE PROVISIONS OF CITY ORDINANCE NO. 32-08-2019

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specifically Article 3, Section 458, Paragraph 3, Sub-Paragraph (v) of its Implementing Rules and Regulations, mandates the Sangguniang Panlungsod to regulate cockfighting and grant license for the establishment, operation and maintenance of cockpits;

WHEREAS, to regulate cockfighting and establishment, operation and maintenance of cockpits, the then Sangguniang Bayan of Tuguegarao enacted 1999 Ordinance No. 04-99, otherwise known as the Cockfighting Ordinance of the Municipality of Tuguegarao, which was amended by City Ordinance No. 08-2005, otherwise known as the "Tuguegarao City Revised Cockfighting Ordinance of 2005," which was amended by City Ordinance No. 32-08-2019 titled An Ordinance Amending Ordinance No. 08-2005, otherwise known as the "Tuguegarao City Revised Cockfighting Ordinance of 2005;"

**WHEREAS**, the Vargas Sports Coliseum with business address at Barangay Pengue-Ruyu, Tuguegarao City is a duly licensed corporate entity under the laws of the Republic of the Philippines;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the application of Mr. John Ryan Vargas Esquillo relative to the legislative franchise to operate the Vargas Sports Coliseum;

WHEREAS, the Vargas Sports Coliseum has complied with the following documentary requirements set forth in Section 8 (A) of City Ordinance No. 32-08-2019 on Franchise Requirements (New):

- a. Board Resolution authorizing the applicant to apply for a legislative franchise to operate the Vargas Sports Coliseum
- b. Location and vicinity plan of the cockpit signed by a licensed geodetic engineer;
- c. Certification from the City Engineer that they have an existing approved building plan/design from their office
- d. Zoning Certification
- e. Certification by the City Building Official that the location/site of the cockpit is beyond the radius of 200 linear meters from any existing hospitals, school buildings, churches or other public buildings
- f. Barangay Certificate issued by Barangay stating that the applicant is a resident thereof
- g. Certified True Copy of Land Title

WHEREAS, after the ocular inspection and series of deliberations, the Vargas Sports Coliseum was compliant as certified by concerned offices such as the City Engineering Office, Bureau of Fire Protection, City Planning and Development Coordinating Office (CPDCO), City Treasurer's Office and Business Permits and Licensing Office pursuant to City Ordinance No. 32-08-2019.

**NOW, THEREFORE**, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Ninth City Council of Tuguegarao City, in session duly assembled, to enact the following:

**SECTION 1. TITLE**. This Ordinance shall be referred to as An Ordinance Granting Legislative Franchise to Vargas Sports Coliseum to Operate a Cockpit in Barangay Pengue-Ruyu, Tuguegarao City for a Period of Three (3) Years Subject to Strict Compliance with the Provisions of City Ordinance No. 32-08-2019."

**SECTION 2. CONDITIONS.** The granting of the legislative franchise to Vargas Sports Coliseum to Operate a Cockpit in Barangay Pengue-Ruyu, Tuguegarao City shall be subjected to the following conditions:

- 1. Franchise period of three (3) years subject to renewal
- 2. Payment of franchise fee/s
- 3. Compliance with all the provisions, conditions and regulations of City Ordinance No. 08-2005, otherwise known as the "Tuguegarao City Revised Cockfighting Ordinance of 2005", and its amendatory ordinance, City Ordinance No. 32-08-2019 An Ordinance Amending Ordinance No. 08-2005, otherwise known as the Tuguegarao City Revised Cockfighting Ordinance of 2005, Local Revenue Code and other rules and regulations set forth
- 4. Operate on Saturdays only starting 9:00 AM and shall end at 12:00 MN without prejudice to the issuance of a special permit to hold derbies/pintakasi on said date and such other dates or holidays not exceeding three (3) days upon payment of the requisite fees and charges
- 5. To clear obstructions in the exit point and to maintain security of the area
- 6. To strictly observe health protocols in the cockpit premises
- 7. Illegal gambling is strictly prohibited inside the premises of the cockpit
- 8. Any violation incurred during the three-year legislative franchise shall be a ground for the revocation of the same

**SECTION 3. RENEWAL OF FRANCHISE**. Renewal of the legislative franchise shall be made within six (6) months prior to the expiration of the said legislative franchise. Failure to renew during the prescribed period shall be considered as a new application.

**SECTION 4. SEPARABILITY CLAUSE.** If any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

**SECTION 5. REPEALING CLAUSE.** City Ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE**. This Ordinance shall immediately take effect upon its approval.

5.) ELECTRICAL INSTALLATION NEEDS IMPROVEMENT.

RECOMMENDATIONS

- : 1.) PROVIDE ADDITIONAL STAIR RAILING GUARD.
  - PROVIDE STEEL MATTING AT OPEN GAP ON UPPER BLEACHERS.
  - 3.) DILAPILATED CEILING NEEDS TO BE REPAIR.
  - 4.) PROVIDE STEEL MATTING RAILING AT TOP MOST PORTION OF BLEACHERS AT LEAST MINIMUM OF TWO METERS HEIGHT.
  - OVER ALL THE BUILDING'S STRUCTURAL ELEMENTS APPEAR TO BE IN GOOD CONDITION.
  - 6.) ELECTRICAL SYSTEM SHOULD BE REGULARLY MAINTAINED
    BY A QUALIFIED ELECTRICAL PRACTISIONERTY COUNCILOR
