**CITY ORDINANCE NO. 23-09-2024**

**CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF SOME PORTIONS OF BAGAY ROAD FROM LAND BANK OF THE PHILIPPINES TO CAGAYAN LEARNING AND RESOURCE CENTER (PROVINCIAL LIBRARY) AND MABINI STREET FROM CORNER LUNA STREET TO GOMEZ STREET FOR THE UNITY PARADE ON AUGUST 01, 2024 FROM 3PM TO 12MN**

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

**WHEREAS**, Tuguegarao City will be celebrating its 300<sup>th</sup> Patronal Feast of Tuguegarao City in honor of its Patron Saint, San Jacinto de Polonia, on August 1 to August 16, 2024;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the temporary road closure of some portions of Bagay Road to Mabini Street from Corner Luna Street to Gomez Street on August 01, 2024 from 3PM to 12MN;

**WHEREAS**, the Traffic and Rerouting Plan aims to establish parking management system and smooth flow of traffic during the activity, provide safety, security and control measure, and traffic monitoring and assistance for the Unity Parade on August 01, 2024;

**WHEREAS**, the Ninth City Council in its 101<sup>st</sup> Regular Session held on July 30, 2024, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval.

**NOW, THEREFORE**, be it **ORDAINED**, by the Ninth City Council in session assembled to enact the following ordinance:

**SECTION 1. TITLE.** This Ordinance shall be known as “**CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF SOME PORTIONS OF BAGAY ROAD FROM LAND BANK OF THE PHILIPPINES TO CAGAYAN LEARNING AND RESOURCE CENTER (PROVINCIAL LIBRARY) AND MABINI STREET FROM CORNER LUNA STREET TO GOMEZ STREET FOR THE UNITY PARADE ON AUGUST 01, 2024 FROM 3PM TO 12MN.**”

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover some portions of Bagay Road FROM Land Bank of the Philippines to Cagayan Learning and Resource Center (Provincial Library) and Mabini Street from Corner Luna Street to Gomez Street on August 01, 2024.


**SECTION 3. INFORMATION.** This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

**SECTION 4. IMPLEMENTATION.** This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.


**SECTION 5. EFFECTIVITY.** This Ordinance shall take effect on August 01, 2024 from 3PM to 12MN.


