CITY ORDINANCE NO. 34-09-2024

AN ORDINANCE DECLARING THE TEMPORARY ROAD CLOSURE OF CORNER ARELLANO STREET AND BONIFACIO STREET FROM 9:00 PM TO 5:00 AM ON DECEMBER 13-15, 2024 FOR THE DISMANTLING OF JOLLIBEE’S PYLON WHICH WAS DAMAGED BY THE SUCCESSIVE TYPHOONS

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of Jollibee Tuguegarao Citimall relative to the closure of the road for the dismantling of its “Pylon” which was damaged by successive typhoons;

WHEREAS, there is a need to close the said streets in the interest of public safety and security of the general public;

WHEREAS, the Ninth City Council during its 118th Regular Session held on December 11, 2024 found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City.

NOW, THEREFORE, be it **ORDAINED** by the Ninth City Council of Tuguegarao in session assembled, to enact:

Section 1. TITLE. This Ordinance shall be known as *“An Ordinance Declaring the Temporary Road Closure of Corner Arellano Street and Bonifacio Street from 9:00 PM to 5:00 AM on December 13-15, 2024 for the Dismantling of Jollibee’s Pylon which was Damaged by the Successive Typhoons.”*

Section 2. SCOPE AND LIMITATION. This Ordinance shall cover corner Arellano Street and Bonifacio Street as subject for closure to pave way for the dismantling of Jollibee’s Pylon.



Section 3. INFORMATION. This Ordinance shall be disseminated through signages and by the City Public Information Office, all mass media outlets and affected barangays in Tuguegarao City.

Section 4. IMPLEMENTATION. The implementing agency shall be the Public Safety and Security Unit (PSSU), Traffic Management Group. Installation of signages and early warning devices shall be done.


Section 5. EFFECTIVITY. This Ordinance shall take effect from 9:00 PM to 5:00 AM on December 13-15, 2024.
