BARANGAY ORDINANCE NO. 1 - 2024

ADOPTING BARANGAY ORDINANCE NO.2 SERIES OF 2020 AUTHORIZING THE CITY OF TUGUEGARAO TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEES IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER

WHEREAS, under Section 152 (C) of the Local Government Code states that;

“(C) Barangay Clearance - No City or Municipality may issue any license or permit for any business or activity unless a clearance is first obtained from the Barangay where such business or activity is located or conducted. For such clearance , the Sangguniang Barangay may impose a reasonable fee. The application for clearance shall be acted upon within seven (7) working days from the filing thereof in the event that the clearance is not issued within the said period, the City or Municipality may issue the said license or permit.”

WHEREAS, the EODB ACT of 2018 Or the Republic Act 11032, otherwise known as “ An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services, Amending for the Purpose of Republic Act No. 9485 “ was duly enacted;

WHEREAS, Section 11 (f) of the above-mentioned Republic Act duly amended the Section 152 (C) of the Local Government Code , and provides that “ Barangay clearances and permits related to doing business shall be applied, issued and collected at the City in accordance with the prescribed processing time of said Act, Provided that the share in the collection shall be remitted to respective Barangays, and

WHEREAS, Barangay Balzain West, (Centro 12), in accordance with the above provisions, and as an implementation of “ ONE STOP SHOP “, hereby authorizes the City of Tuguegarao particularly Business Permits and Licensing Office (BPLO) to issue Barangay Clearance and collect corresponding Barangay clearance fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the Barangay and the conditions hereunder.

NOW THEREFORE, be it **ORDAINED** as it is hereby **ORDAINED** by the Barangay Council of Balzain West, (Centro 12), in a session duly assembled the following :

SECTION 1. Coverage. This policy applies only to the issuance of Barangay Clearance for business permit and locational clearance (as a requirement for the issuance of building permit) at the City/ Municipality. Other clearances for other purposes shall still be obtained at the Barangay.

This circular shall cover all City and Municipal Mayors, Punong Barangays, Concerned Local Officials, DILG Regional Directors and BARMM Minister of Local Government and all other concerned.

SECTION 2. Definition of Terms. The words and phrases used in this ordinance are hereby defined as follows ;

Barangay Clearance - refers to any and all documents issued by the Barangays with or without corresponding fees as defined in their ordinances relative to or in relation to the issuance of business permit and locational /zoning clearance by the City or any other permit as may be required, (IRR of RA 11032).

Barangay Clearance Fees - is an amount imposed by the Barangay through an Ordinance and collected by the City in relation to the issuance of business permit and locational/zoning clearance by the City.

Business Permit - is a document that must be secured from the City Government usually through its Business Permits and Licensing Office (BPLO), for a business to legally operate in the locality. (IRR of RA 11032).

Locational Clearance - is a clearance issued by the Zoning Administrator Officer to to a project that is allowed under the provisions of an ordinance of a particular City. It is a requirement for the issuance of Building Permit. (House and Land use Regulatory Board) - Comprehensive Land Use Plan (Guidebook).

SECTION 3 - Authority to collect Barangay Clearance Fee of Business Related Transactions - The City of Tuguegarao is given authority to Collect Barangay Clearance for subject to the remittance to the subject Barangay.

SECTION 4. Rate of Barangay Clearance Fee to be collected - The rate of Barangay Clearance Fee to be collected by the City for the issuance of clearance shall be computed in accordance with the subject Barangay Revenue Ordinance Chapter V Article 1 Section 30 attached herewith Business Tax and Occupational Clearance.

SECTION 5. Barangay Clearance Signatory - Electronic Signature of Punong Barangay concerned shall appear in all Barangay Clearance issued.

SECTION 6. Reporting and Remittance - The City shall remit the Barangay Clearance fee collected to the subject Barangay not later then seven (7) working days of the ensuing month with the list of the issued Building and Business Permit.

SECTION 7. Separability Clause - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 8. Repealing Clause - All previous Ordinance and rules/regulations which are inconsistent with the provisions of the ordinance are hereby deemed, modified or repeated accordingly.

SECTION 9. Effective Clause – This ordinance shall take effect fifteen (15) days after its publication.

BARANGAY ORDINANCE NO. 2 - 2024

AN ORDINANCE UPDATING A REVENUE CODE OF BARANGAY BALZAIN WEST (CENTRO 12), TUGUEGARAO CITY, PROVINCE OF CAGAYAN.

BE IT ENACTED by the Sangguniang Barangay of Barangay Balzain West (CENTRO 12), Tuguegarao city, Province of Cagayan that:

CHAPTER 1 – GENERAL PROVISIONS

Article I – Title

Section 1. Title – This Ordinance shall know and cited at Revenue Code of Barangay Balzain West

(Centro 12), Tuguegarao City, Province of Cagayan.

Section 2. Scope of Application – This Code shall govern the levy, Assessment and Collection of Taxes, Fees and Charges. And other imposition within the territorial limits of Barangay Balzain West (Centro 12), Tuguegarao City, Province of Cagayan.

Article II – Definition of Terms and Rules of Construction

Section 3. Definitions – When use in this Code, the term:

Business – Means Trade or Commercial activity regularly engaged in as a means of livelihood or with a view to profit.

Canteen – refers to any public eating place where foods already cooked or served at a price.

Capital – Signifies the actual estate, whether a money or property owned by an individual or corporation; it is fund with which is transact its business, which would be liable to each creditor, and which case of insolvency passes or to receiver.

Charges – Refer to pecuniary liability, as rents or fees against persons or property.

Dealer – Means one whose business is to buy and sell merchandise, goods and chattels as a merchant. He stands immediately between the producer or manufacturer and the commodities.

Fees – Means any charges fixed by law or ordinance for the regulation or inspection of a business or activity. It is also include charges fixed by law or agency for a service of public officer in the discharge of his official duties.

Gross Sales or Receipts – Include the total amount of money or its equivalent representing the contract price, compensation or service fee, including the amount charge or material supplied with the services and deposits or advance payments actually or constructively received during the taxable quarter for the services performed for another person excluding discount if determinable at the time of sale. Sales return, Excise Tax and Value Added Tax (VAT)

Levy – Means Imposition and Collection of Assessment, Tax, Tribute, or Fine.

License or Permit – Is a Right or Permission granted in accordance with the law or by competent authority to engage in some business or occupation or to engage in some business or occupation or to engage in some traction.

Motor Vehicle – means any vehicle propelled by any power other than any muscular power using the public roads but excluding road roller, trolley cars, street-sweepers, and sprinkles.

Operator – Include the Owner, Manager, Administration or any other person who operates or it's responsible for the operation of business establishment or undertaking.

Persons – Means every Natural or Judicial being, susceptible of rights and obligation of being the subject of legal relations.

Residents - Refer to natural persons who have habitual residence in the barangay where they exercise their civil rights and fulfil their civil obligation, and to juridical person for which the law or any provisions creating or recognizing them fixes their residence in the barangay. In the absence of such law, juridical persons are residents of barangay if they legal residence or principal place of business or if they conduct their principal business or occupation in the barangay.

Retail - Means a sale where the purchaser buys the commodity for his own consumption, irrespective of the quantity of the commodity sold.

Retail Store - Are business establishment with fixed business address in the barangay where goods are kept for sale to purchasers for personal consumption.

Revenue - Includes Taxes, Fees, and others charges that the state or political subdivision collects and receives into the treasury for public purposes.

Services - Means the duties, work or function performed or discharged by a government officer or any private person contacted by the government

Tax - Means an enforced contribution usually monetary in form, levied by the law making body on person and property subject to its jurisdiction for the precise purpose of supporting government need.

Boarding House - A private house providing food and lodging paying guest.

Section 4. Words or Phrase Not Herein Expressly Defined - Words and Phrases embodied in this Code not herein specifically defined shall have the same definitions as found in Republic Act 7160, otherwise known as the Local Government Code of 1991, and its implementing Rules and Regulations as well as in other applicable laws.

Section 5. Rules and Construction - In constructing the provision of this Code, the following rules of construction shall be observed unless inconsistent with the manifest intent of the provisions or when applied they would lead to absurd or highly improbable result.

A. **General Rule** - All words or phrases shall be construed and understood according to common and approved usage of the language; but technical words or phrase and such other words in this code which may have acquired a peculiar or appropriate meaning shall be construed and understood according to such technical, peculiar meaning.

B. **Gender and Number** - Every word in this code importing the masculine gender shall be extending to both male or female. A word in singular number shall apply to several persons or things and every words importing the plural number shall extend and apply to one person or thing.

C. **Computation of Time** - The time within the which act is to be done as provided in this code or in any rules or in any rules or in regulation issued pursuant to the provision when expressed in days shall be computed by excluding the first day and including the last day, except when the last day falls on Sunday or Holiday in which case, the same shall be excluded from the computation, and the next business day shall be considered the last day.

D. **References** - All references to Chapters, Articles, and Sections are to Chapter, Articles and Sections in this code unless otherwise specified.

E. **Conflicting Provision of Section** - If the provision of the different sections in the same chapter conflict with each other, the provision of the section which is the point of sequence shall prevail.

CHAPTER II - BUSINESS TAX

Article 1 - Tax on Retail Store or Retailers

Section 6. Imposition of Tax - There hereby levied and annual tax on store or retailers with gross sales or receipt for the proceeding calendar year to ₱ 50, 000.00 or less the rate one percent (1%) of such gross receipt or sale.

Section 7. Time of Payment and Accrual of Tax - The tax imposed herein shall accrue on the first day of January of each year as regards subjects then liable therefore.

Section 8. Collection of Taxes - The tax must be paid to, and collected by the Barangay Treasurer or her duly authorized representative before any business or trade activity herein specified can be lawfully begun or pursued and the tax shall be reckoned from the beginning of the calendar year. When the business is abandoned, the tax shall be enacted for a period longer than the end of the calendar quarter. When the tax has been paid for a period longer than the current quarter and the business, or trade activity, is abandoned, no refund of the tax corresponding to the unexpired quarter shall be made.

Section 9. Surcharge for the Late Payment and Interest on Unpaid Taxes - failure to pay the described in this article within the time required shall subject the tax payer to a surcharge of twenty-five percent (25%) of the original amount to tax due.

Such surcharge shall be paid at the time and in the same manner as the original tax due. In addition to surcharge imposed herein, there shall be imposed of interest of two percent (2%) per month from the date is due until fully paid, provided that in no case shall the total interest on the unpaid amount or portion thereof exceed thirty six (36) months.

Where an extension of time for the payment of the tax have been granted and the amount is paid in full prior for the expiration of the extension, the interest aforementioned shall be collected on the amount from the date it becomes originally due until fully paid.

Section 10. Administrative Provisions; Rules and Regulations:

A. Any person who shall established or operate any retail store in the Barangay shall first obtain a mayors permit and pay the fee prescribe therefor and the business tax imposed under this article.

B. Shall secure business certification to the barangay prior securing mayor's business permit.

C. **Issuance and Posting of Official Receipt.** The Barangay Treasurer shall issues an official receipt upon payment of the business tax imposed herein. Issuance of the said official receipt shall not be relieve the tax payer from the requirement being imposed in the barangay under existing city ordinance rules and regulations.

Every person issued an official receipt for the conduct of business or undertaking shall keep the same conspicuously posted in a plain view at the place of business or office, he shall keep the official receipt in his person. The receipt shall be produced upon the

demand of the Punong Barangay, Barangay Treasurer or their duly authorized representatives.

In acknowledging barangay taxes, fees and charges, it shall be duty of the Barangay Treasurer or his Deputy to indicate the official receipt issued for the purpose, the number of the corresponding tax ordinance .

D. Issuance of Certificate. The Barangay Treasurer may upon presentation of the satisfactory proof that the original receipts been lost, stolen or destroy, issue a certification to the effect that the tax has been paid, indicating therein, the issued, upon payment of fifty (₱ 100.00) pesos.

E. Transfer of business to other location. Any business for which a barangay tax has been paid by the person conducting it may be transferred and continued in any other place within the territorial limits of this barangay without paying any additional tax during the period for which payment of the tax was made.

F. Death Licensee. When any individual paying a business tax is died, the business is continued by a person interested in his state. No additional payments shall be required for the residue of the term for which the tax was paid.

Section 11. Newly Started Business - In the case of newly started business subject of its article, the initial tax shall be One Hundred Pesos (₱ 200.00) payable to the Barangay Treasurer upon application of permit to operate the business. In the succeeding year, the tax payment shall be based on the immediate proceeding year, whereby the initial tax payment shall be applied as tax credit to the total assessment for the taxable year.

Section 12. Penalty - Any violation of the provision of this article shall be punished by a fine of Three Hundred Pesos (₱ 300.00) but not exceeding to Five Hundred (₱ 500.00) at the discretion of the Punong Barangay.

CHAPTER III - REGULATORY FEES

Article 1 - Fees on Transfer of Retail Business

Section 13. Imposition Fee - There hereby levied a fee on the transfer of retail store subject of the proceeding article through sale, donation, barter, any mode or form of conveyance at the rate of (1%) of the total consideration or in the absence of specific consideration , the gross sale or receipt of the proceeding calendar year on file of the Barangay Treasurer's records or fixed amount of Five Hundred Pesos (₱ 500.00) which over is lower.

Section 14. Rules and Regulations:

A. The new owner to whom the business was transfer shall be liable to pay the unpaid taxes, fees or charge due the former owner.

B. The permit issued to the former shall be surrendered to the City Treasurer, thru the office of the Mayor, who shall cancel the same in his records.

C. Any person who was granted a permit to operate or conduct a retail store in this baranagay who transferred his business to another shall inform in writing the Barangay Treasurer or to the Punong Barangay, within ten (10) days of such transfer.

D. The Punong Barangay shall issue other necessary rules and regulations for the effective implementation of this article.

Section 15. Time of Payment - The fee imposed in this article shall be paid the Barangay Treasurer by the buyer, done or heir before the business or trade undertaking is operated or pursued.

Section 16. Surcharge for Late Payment and Interest on Unpaid Fees - Failure to pay the prescribed in this article within the time required will be subject the tax payer to twenty five percent (25%) of the original amount of fee due.

Such surcharge shall be paid at the same time and in the same manner as the original fee due. In addition to the surcharge imposed herein, there shall be imposed and interest of two (2%) per month from the date it is due until its fully paid, provided, that in no case shall be the total interest in the unpaid amount or portion thereof exceed thirty six (36) months.

Article II - Regulatory Fees on Outdoor Advertisement

Section 17. Imposition Fees - There is by imposed an annual regulatory fee on outdoor advertisement displayed or maintained in any place exposed to the public view within a territorial jurisdiction of this barangay, at the following rates.

A. Billboards or Signboards for advertisement of business, per square meter of fraction thereof.

Single Faced - ₱ 100.00/square meter

Double Faced - ₱ 200.00/square meter

B. Billboards , Signs or Advertisement of Business and Professionals, painted or any or structure or otherwise separated or detached there from square meter thereto - ₱ 100.00

Additional Imposition :

Privileged panels shall be subject to one half (1/2) of the rate prescribed above.

Section 18. Exceptions - The imposition of the above prescribed rates is subject to the following exemptions:

Signs, signboards, advertisement including stick out, streamers, lighted signs and other electronic media posters, privilege panels, store signs, placard, price strips, buntings, and the like belonging to manufacturers or producers or professionals, but displayed on delivery or other service and public utility vehicles are exempted from the provision of this article.

Section 19. Time Payment - The Fee imposed in this article shall be paid to the Barangay Treasurer within the first Twenty (20) days of January of every year.

Section 20. Surcharge for Late Payment and Interest on Unpaid Fees - Failure to such surcharge shall be paid at the same time and in the same manner as the original fee due.

In addition to the Surcharges imposed herein, there shall be an imposed interest of two percent (2%) per month from the date it is due until it is fully paid, provided that in no case shall the total interest on unpaid amount or portion thereof exceed thirty six (36) months.

Section 21. Administrative Provision - Installation and construction of billboards, signboards and the like shall be subject to the provision of existing City Ordinance, rules and regulations in this matter.

Section 22. Penalty - Any violation of the provision of this article shall be punished a fine of Three Hundred Pesos (P 300.00).

CHAPTER IV - SERVICE CHARGE AND REGISTRATION FEES

Article 1 - Clearance or Certificate

Section 23. Imposition of Fee - There shall be collected for the issuance of a clearance or certification of the Punong Barangay or his duly authorized representative, the following fees:

Section 24. Exception - No fee shall be collected for the issuance of certification or clearance when it is officially requested by any court or government agency.

Section 24. Time Payment - The Fee imposed in this article shall be paid to the Barangay Treasurer within the first Twenty (20) days of January of every year.

Section 26. Administrative Provisions - Issuance of barangay clearance for any business or trade activity located or conduct within the territorial jurisdiction of this barangay as a requirement before the mayor's issues a license or permit shall be acted upon within seven (7) working days from the filling thereof.

Section 27. Endorsement by the chairman of the Appropriate Committee of the Sangguniang Barangay - The endorsement of the chairman of Appropriate Committee of the Sangguniang Barangay shall be required before a barangay clearance is issued for any trade or activity located/conducted within the territorial jurisdiction of this barangay.

Article II - Lupon Filing Fee

Section 28. Imposition of Fee - There is hereby imposed filing for any dispute brought before the Lupon ng Tagapamayapa of this barangay subject for amicable settlement, mediation, conciliation or arbitration by the Lupon ng Tagapamayapa at the following rate:

Section 29. Time Payment - The fee imposed in this article shall be paid to the Barangay Treasurer at the time of filing of the complaint. The Barangay Treasurer shall issue a necessary receipt thereof.

CHAPTER V - REGULATORY FEES AND CHARGES

Article I - Barangay Clearance for Business Certificate/Permit

Section 30. Imposition of Fee - There shall be collected fees at the provided hereunder for the issuance of Baranga Clearance/Permit to every person that shall conduct or operate a business, trade or activity within the territorial jurisdiction in this barangay.

Section 31. Time Payment - The fee imposed herein for the issuance of Barangay Clearance/Permit shall be paid to the Barangay Treasurer before any business or activity be pursued in the barangay prior to the issuance of any City License Permit for any business activity located or conducted in this barangay.

CHAPTER VI - SERVICE FEES CHARGE

Article I - Charge for the use of Barangay Facility

Section 32. Impose of Fees - There shall be collected of fee for the use of barangay facility:

Function Hall fully Air-conditioned & Sound System -----	₱ 1,000.00
Basketball Court with Lights -----	₱ 300.00/game

Section 33. Time of Payment - The fee impose herein shall be paid in the Barangay Treasurer or his duly authorized representative upon securing a permission from the Punong Barangay.

Section 34. In case of damage to the facility shall be borne the lessee.

CHAPTER VII - GENERAL ADMINISTRATION AND PENAL PROVISION

Article I - Collection and Accounting of Barangay Revenues

Section 35. Collection. The Collection of barangay taxes, fees, charge, surcharge, interest and penalties accruing to this barangay shall be.

Unless otherwise specifically provided in the code or under existing laws or decrees, the Barangay Treasurer is authorized, subject to the approval of the Punong Barangay and concurrence of the Sangguniang Barangay to promulgate rules and regulations for the proper and efficient administration and collection of taxes, fees and charge herein imposed.

Section 36. Issuance of Receipt - It shall be duty of the Barangay Treasurer or his authorized representative to issue the necessary receipt to the person paying the taxes, fees and charge, indicating therein the date, amount, name of the person and the account for which it is paid.

Article II - General Penal Provisions

Section 37. Penalty - any violation of the provision of this code not herein other wise covered by specific penalty of the rules and regulations promulgated under this code, shall be punished by a fine of not less than Three Hundred Pesos (₱ 300.00) but not exceeding to Five Hundred Pesos (₱ 500.00) at the discretion of the Punong Barangay.

Payment of fine herein provided shall not relieved the offender from the payment of the delinquent tax, fee or charge imposed under the code.

If the violation is committed by any juridical entity, the President, general manager or any persons entrusted with the administration thereof at the time of the commission of the violation shall be held responsible or liable thereof.

Section 38. Compromise Settlement Fee - The Punong Barangay is hereby authorized to enter into an "extra judicial" or out court settlement of any offence involving violations of any provisions of this code subject, however to the following conditions to wit:

- A. That the offence does not involve fund
- B. That the offender shall pay a settlement fee of not less than Tree Hundred Pesos (₱ 300.00) but not more than Five Hundred Pesos (₱ 500.00) as may be agreed upon the parties.

CHAPTER VIII - FINAL PROVISION

Article I - Miscellaneous Provisions

Section 39. Transitory Provision - Every business establishment operating without a Barangay Clearance/Permit prior to the approval of this code secure a Barangay Clearance/Permit and pay the corresponding security fee within Twenty (20) working days after the effective of this code.

Section 40. Separable Clause - If for any reason, any provision, section or part of this code is declared not valid by a court of competent jurisdiction or suspended or revoked by the Sangguniang Panlungsod, such judgement shall not effect or continue to be in full force or effect.


Section 41. Applicable Clause - All other matters relating to the impositions in this code shall governed by pertinent provisions of existing laws and other ordinance.

Section 42. Repealing Clause – All ordinance, rules and regulation, or parts thereof, in conflict with or inconsistent with any provisions of this code, are hereby repealed amended or modified accordingly.

Section 43. Effectivity – This Code shall take effect upon approval.

AN ORDINANCE TO OFFICIALLY NAMED SOME STREET IN BARANGAY BALZAIN WEST (CENTRO 12), TUGUEGARAO CITY, CAGAYAN

Sponsor: SB Mem. TORSTEN HAMYL S. MORA

WHEREAS, Section 13 of chapter 11 of RA 7160 provides local government units to name streets, roads and alleys within the Barangay.

WHEREAS, problems and confusion arises due to lack of identification of an area to delivery of postal matters and even the local treasury and sheriffs;

WHEREAS, there is a need to name these unnamed streets to locate them easily ;

WHEREAS, it is also fitting that a street be named after those whose lot emanated some unnamed streets.

WHEREAS, to provide solution to the aforementioned concerns, there should be an immediate action for the naming of streets as follows :

ZONE 7 - a street going to Zone 7 interior along Lopez Compound is Mangga Street and the other way at left side of Lopez Compound is Santol Street.

ZONE 6 - Interior going to Revero and Culili Compound is DIVERSION INTERIOR.

ZONE 6 - Along Boydon Compound is EGIPTO Street. This is in honor of the late FELISA EGIPTO GONONG residents/owner from who the lot emanates.

ZONE 4 - Along Laggui Compound will be named LAGGUI INTERIOR named after the owner of the land Peter Laggui.

ZONE 4 - Along Sisip Compound is ROSAL Street

ZONE 4 - Beside basketball Court going out to Motolite is SANTAN Street.

ZONE 3 - Going to Abadu Compound is DAHLIA Street
Going to Barangay Hall is FUGABAN Street, in honor for the late owner
from whom the lot emanates.
Along Ballard residence is BOUGAINVILLEA Street
Along Cardenas residence is SAMPAGUITA Street
Along Soriano residence is SUNFLOWER Street
Going to Notario residence is CAMIA Street

BE IT ORDAINED, therefore, by the Sangguniang Barangay of the Barangay Balzain West (Centro 12), in session duly assembled, that:

SECTION 1. – For the identification of the exact names or official names of the following streets.

SECTION 2. – The barangay shall submit to the City Planning and Development Office all the names of the unnamed streets to be incorporated in the map of the City.

SECTION 3. – EFFECTIVITY CLAUSE - This ordinance is effective immediately upon its approval.


