# MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made and entered into on this 14<sup>th</sup> day of June 2025 by and between:

## PURPOSE & SCOPE.

The purpose of this Memorandum of Agreement is to set forth the terms and conditions, scope of work and responsibilities of the parties in the establishment of Amusement activities or "Perya".


## TERMS & CONDITIONS.


It is mutually understood and agreed by and between the parties that:

1. The "perya" shall be established within the barangay grounds for the period July 15, 2025 to August 30, 2025 in celebration for the Patronal Feast;
2. The proprietor MR. DANIE A. NARAG JR. shall pay a total amount of Twenty Thousand Pesos(P20,000.00) to Barangay Annafunan East, Tuguegarao City as fee within the agreed period which will be used for the celebration activities of the barangay;
3. Barangay Annafunan East shall ensure the safety and security of the "perya" operators while operating within the barangay;
4. The perya operators shall ensure peace and order in the barangay and prevent any illegal and prohibited activities while operating for the said period;
5. This MOA may be amended from time to time by mutual agreement of the parties in a written modification signed by both parties;
6. This MOA may be terminated by mutual agreement of the parties, and shall automatically terminate upon completion of all responsibilities as stated herein, unless otherwise amended.
