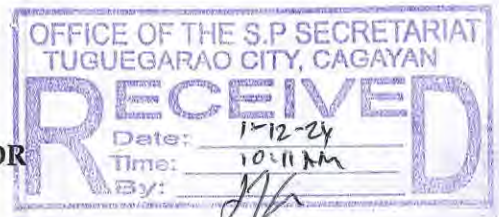


WHEREAS, on the outer circle, BARANGAY LEONARDA, TUGUEGARAO CITY is proudly written as a symbol of honor and distinction.

A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BARANGAY OF BARANGAY LEONARDA, TUGUEGARAO CITY, CAGAYAN

WHEREAS, the Sangguniang Barangay Leonarda Internal Rules Procedures are necessary in order to govern the orderly conduct of the members of the Sangguniang Barangay;

WHEREAS, the promulgation of these rules is imperative in the efficient discharge of the powers, duties and functions of the members of the Sangguniang Barangay, pursuant to the pertinent provisions as found therein in the Local Government Code of 1991(RA 7160)

NOW THEREFORE, on motion of Kagawad Socorro De Los Santos, duly seconded by Kagawad Susie Odon Pamittan, be it resolved as it is hereby resolved, to adopt the following Internal Rules of Procedure of the Sangguniang Barangay of Barangay Leonarda.

RULE I. MEMBERSHIP

Section 1. COMPOSITION

The officials of Barangay Leonarda are composed of the Punong Barangay, the seven (7) Sangguniang Barangay members, the Sangguniang Kabataan Chairman, the Barangay Secretary and the Barangay Treasurer (Sec. 387, RA 7160).

Section 2. TERM OF OFFICE

The term of office of the Sangguniang Barangay Leonarda shall be two 2 years which command on November 1, 2023. This term of office may be extended by virtue of national proclamation.

Section 3. OATH OF AFFIRMATION

The Punong Barangay as Chairman, the regular members of the Sangguniang Barangay, the SK Chairman, the Barangay Secretary and Treasurer shall assume office on the day and in the manner as provided for by law.

RULE II. PRESIDING OFFICER

Section 1. PUNONG BARANGAY

The Punong Barangay shall be the Presiding Officer of the Sangguniang Barangay. The Presiding Officer shall vote only to break a tie.

In the event of inability of the Punong Barangay to preside over the session, the Barangay Kagawad who is first in rank shall preside the session.

Section 2. POWER AND DUTIES

The powers, duties and functions of the Punong Barangay are provided by Sec. 389 of RA 7160.

1. Chief Executive: Powers, Duties, and Functions.

- a) The Punong Barangay, as the chief executive of the Barangay Government, shall exercise such power and perform such duties and functions, as provided by code and other laws.
- b) The efficient, effective and economical governance, the purpose of which is the general welfare of the Barangay and its inhabitants pursuant to Section 16 of this Code, the Punong Barangay shall:
 - i. Enforce all laws and ordinances which are applicable within the barangay;
 - ii. Negotiate, enter into, and sign contracts for and in behalf of the barangay, upon authorization of the Sangguniang Barangay;
 - iii. Maintain public order in the barangay and, in pursuance thereof, assist the City or Municipal Mayor and the Sangguniang Members in the performance of their duties and functions;
 - iv. Call and preside over the sessions of the Sangguniang Barangay upon the Barangay Assembly, and vote only to break a tie;
 - v. Upon approval by a majority of all the members of the Sangguniang Barangay, appoint or replace the Barangay Treasurer, the Barangay Secretary, and other Appointive Barangay Officials;
 - vi. Organize and lead an emergency group whenever the same may be necessary for the maintenance of peace and order or on occasions of emergency and calamity within the Barangay;
 - vii. In coordination with the Barangay Development Council, prepare the annual executive and supplemental budgets of the barangay;
 - viii. Approve vouchers relating to the disbursement of barangay fund;

- ix. Enforce laws and regulations relating to pollution control and protection of the environment;
- x. Administer the operation of the Katarungang Pambarangay in accordance with the provisions of this Code;
- xi. Exercise general supervision over the activities of the Sangunian and Kabataan;
- xii. Ensure the delivery of basic services as mandated under Section 17 of this Code;
- xiii. Ensure the delivery of basic services as mandated under Section 17 of this Code;
- xiv. Conduct an annual palamong barangay which shall feature traditional sports and disciplines included in National and International games, in coordination with the Department of Education, Culture, and Sports;
- xv. Promote the general welfare of the barangay;
- xvi. Exercise such other powers and perform such other duties and function as may be prescribed by law or ordinance.

- c) In the performance of his peace and order functions, the Punong Barangay shall entitled to possess and carry the necessary firearm within his territorial jurisdiction, subject to appropriate rules and regulations.

RULE III. THE SANGGUNIANG BARANGAY

Section 1. Composition. The Sangguniang, the legislative body of the barangay, shall be composed of the Punong Barangay as Presiding Office, and the seven (7) regular Sangguniang Barangay members elected at large, the SK Chairman(ex-oficio) as members (Sec. 390, RA 7160)

Section 2. The powers, duties and functions of the Punong Barangay are provided by Sec. 389 of RA 7160.

Section 3. The other duties of the Sangguniang Barangay members are provided for by Sec. 392 of RA 7160.

RULE IV. APPOINTIVE BARANGAY OFFICIALS

Section 1. Barangay Secretary. The appointment, qualifications, powers and duties of the Barangay Secretary are provided for by Sec. 394 of RA 7160.

Section 2. Barangay Treasurer. The appointment, qualifications, powers and duties of the Barangay Treasurer are provided for by Sec. 394 of RA 7160.

RULE V. THE STANDING COMMITTEES

Section 1. **The Committees.** The creation and composition of the standing committees in the Sangguniang Barangay shall be the first order of business for the Sangguniang Barangay. The following are the standing committees of the Sangguniang Barangay:

- 5) COMMITTEE ON SOCIAL SERVICES, WELFARE, WOMEN AND CHILDREN
- 6) COMMITTEE ON PEACE AND ORDER
- 7) COMMITTEE ON AGRICULTURE, FISHERIES AND LIVELYHOOD
- 8) COMMITTEE ON YOUTH, SPORTS DEVELOPMENT AND EDUCATION

Section 3. **Committee Chairmanship.** a) A Sangguniang Barangay member may hold one or more committee chairmanship upon approval of the majority. b) The Punong Barangay, may choose to, upon approval by the majority of the Barangay Council, hold chairmanship in any of the above committees in the event that no Council member is available for the said position.

Section 4. In the event of reorganizing the Committees, the Chairmanship and Membership of the committee shall be determined by a majority vote of all the members of the Barangay Council.

Section 5. The powers, duties and functions of the following committees are as follows;

1) COMMITTEE ON FINANCE AND APPROPRIATION - With jurisdiction regarding all matters relating to budget, appropriation and the expenditure of funds as found in the Annual Budget and Supplemental Budgets of the Barangay.

2) COMMITTEE ON PUBLIC UTILITIES AND TRANSPORTATION – With jurisdiction in raising other funding requirements for the Barangay, including fund raising for barangay programs and activities and the management of funds raised from the same.

3) COMMITTEE ON PUBLIC WORKS AND INFRASTRUCTURE – Planning, construction, maintenance, improvement and repairs of public buildings, roads, parks, basketball courts and gyms, playground and other public buildings; drainage, sewerage, seawall and sea swell control and protection, irrigation and water facilities.

4) COMMITTEE ON URBAN PLANNING AND LAND USE – Duty to deal with matters relating to land use and applications, land disputes and cases, subdivision development and real estate development and tourism growth and development.

5) COMMITTEE ON HEALTH AND SANITATION – Measures and programs to ensure delivery of health services, all matters related to procurement of medicines and provisions for indigents; health services for the disadvantage groups, including the elderly, the disabled, street children and drug dependents.

6) COMMITTEE ON SOCIAL SERVICES WELFARE, WOMEN AND CHILDREN – The provision for basic social services, especially medical and financial assistance to indigent patients and their families, in coordination with the LINGAP program of the City Government, other forms of financial assistance to indigents and senior citizens, feeding programs and other programs concerning public and social welfare.

7) COMMITTEE ON PEACE AND ORDER – Maintenance of peace and order, fire prevention and control measures and all other matters related to peace and order and public safety, including mitigating to impact of calamities and quick response team creation and dispatch.

8) COMMITTEE ON AGRICULTURE AND FISHERIES DEVELOPMENT & LIVELIHOOD – Development of the agriculture and fisheries sectors in the barangay, urban gardening, livelihood creation and support, support and maintenance of the bantay-dagat, programs and support mechanism for small fishermen and farmer in the barangay, in coordination with the Barangay Fisheries and Aquatic Resources Management Council.

RULE X. DISCIPLINE OF MEMBERS

Section 1. Any member of the Sangguniang Barangay found guilty of disorderly conduct by any competent court. Or commits acts of dishonesty, negligence, corruption or violates any of the grounds as found therein in pertinent laws, or incurs absences without justifiable cause for beyond three consecutive regular sessions, may be censured, reprimanded and suspended for not more than sixty (60) days, or expelled upon the decision of any competent Court of Law (Sec. 60 RA 7160). The procedure as stated in the said section of RA 7160 shall be observed.

RULE XI. AMENDMENTS TO RULES

Section 1. These Internal Rules of Procedure may be amended at any regular session by a 2/3 vote of all the Sangguniang Barangay members.

RULE XII. MISCELLANEOUS PROVISIONS

Section 1. Repealing Clause. All previous Internal Rules of Procedure passed by the Sangguniang Barangay are hereby repealed, amended or modified accordingly.

Section 2. Separability Clause. If, for any reason or reasons, any part of provision of this ordinance shall be held to be unconstitutional or invalid, other parts of provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 3. Effectivity Clause. This internal Rules of Procedure shall take effect after its approval by the majority members of the Sangguniang Barangay of Leonarda, reviewed and approved by the Sangguniang Panlungsod.


